Following translation of contact report is quoted:

July 15, 1932.

From: 2nd Lieut Isidro Sandino.

To: The Jefe Director, Guardia Nacional de Nic.

Subject: Patrol and contact report.

Reference: General Order #109, (2nd Brigade Map).

- armed bandits with rifles and pistols under Colonel Ruperto Hernandez Roblero had passed Robledalitos (223-349). The bandits sacked the town stealing cows, pigs, three horses, clothing and then cleared toward Zancudal (227-351).
- 2. I contiguously reported to the District Commander at Condega. Received orders from the District Commander to wait for 2nd Lieut Orlando Lopez GN., who was ordered to clear Condega with twenty enlisted and with six other enlisted from the Detachment of Daraili, to persecute the bandits.
 - At 17310, Lieut Lopez and twenty enlisted arrived to Daraili. Cleared at 20310, 2nd Lieut Isidro Sandino h. as patrol commander, and Lieut Orlando Lopez as 2nd Jefe of the patrol, twenty enlisted from Condega and six enlisted from Daraili. Arrived Robledalito (223-349) at 06311, rested there until 14011. Information was given to us that Colonel Ruperto Hernandez Roblero with a group of more than one hundred well armed with Krag and Con-Con rifles, dynamite bombs, rifle grenade dischargers, had passed through the valley stealing on their way and then had cleared for Zencudal (227-351). Cleared at 14011 for point 227-351 and arrived at 23011. Were informed at Zancudal that the bandits were headed for El arco (231-354). Cleared El Zancudal for El Arco at 06312 and arrived at 17012. We were informed at that place that the bandits were directed for Los Portillos and La Pavona (237-345). Rested at El Arco until 06313 when we cleared for Los Achotales. Arrived at Gamalote (226-348) at 16313 but no information could be obtained there. Cleared Gamalote for Los Achotales and arrived at 23313. Received information that the bandits were camped at La Pavona (237-345). Cleared at 06014 for La Pavona.
 - 4. At 07014, we were attacked by the bandits, their firing line had about 300 yards long. They employed Krag rifles, two STMGs, two Rifle Grenade Dischargers and dynamite bombs. The contact lasted one hour and thirty minutes. Lieut Lopez was wounded at the begining of the contact, also Reso Arcadio Castillo #3385, Raso Sotero Zelaya #3168 and Raso Gabriel Altamirano #3997.
 Raso Humberto Martinez #4115 was killed by the exploding of a dynamite bomb which was thrown by the bandits. During the contact the bandits shouted "vivas" to General Salgado and to Colonel Ruperto Roblero. After the bandits were rushed from

their positions, they were pursued for half an hour. There were twelve bandits killed, including Colonel Ruperto mernandez Roblero; important correspondence from Sandino and other jefes was found on him. It is believed that the bandits had many wounded due to the many blood trails that were found.

- 5. Bandit casualties: 12 killed including Colonel Ruperto Hernandez Roblero.

 Articles captured: correspondence, two Krag rifles in good shape, one Con-Con rifle also in good shape, fuses, six horses and many other miscellaneous articles.
- 6. Guardia casualties: Raso Humberto Martinez #4115 killed by the exploding of dynamite bomb thrown by the bandits; after he was seriously wounded and almost dying he fired twice against the bandits. Lieut Lopez, wounded in his face from a .32 caliber pistol shot, he was wounded at the first burst of fire from the bandits but in spite of being seriously wounded he continued fighting until the end. Raso Arcadio Castillo #3385 was wounded at the first burst of fire in his face and on one foot. Raso Gabriel Altamirano #3997 was also wounded at the begining. Raso Sotero Zelaya #5168, who after being wounded and when his BAR jammed, stripped his Automatic Weapon, reduced the jam and continued his automatic fire until the end of the contact.
 - 7. Arms employed by the Guardia during the contact: One BAR, Three STLGs, three rifle grenade discharders and 19 Krag rifles.

- Cleared this station at 0800 11 June to operate on local information of Bandit Camps in vicinity point 238-365. Informants stated that Salgado with 100 well armed was in camp of Sixto acuña in this vicinity. Arrived at a point two hundred yards from camp at 1130 and captured correo who had just left the camp with the enclosed message which he attempted to destroy. Proceeded to the camp and attacked at 1200. Owing to the density of the under brush was unable to surround the camp or to employ more than six of the patrol in the preliminary attack. The bandits had no sentries posted and we were able to approach within fifty yards before the Bandits saw us and opened fire. We replied and rushed to the edge of the camp where we formed a firing line. When sufficient members of the patrol arrived at the firing line we rushed the camp and the bandits retreated in small groups into the brush and formed a new firing line. We rushed the new firing line and the bandits fled in all directions.
- 2. The camp consisted of seven shacks, total capacity about 85 men. The captured correo stated that there were 100 men in the camp when we attacked. I estimated the number at 50. The following articles were captured of destroyed:

1500 pounds Shelled corn.

800 Beans.

800 " Coffee.

100 " Cheese.

15 new blankets, civilian. 65 number #8 dynamite caps.

20 pounds Hercules black powder.

Miscellaneous articles of clothing and small amount of medicine.

There were four women in the camp who stated that the bandits were preparing to clear for Acuñas, other camp at the time of the attack. I believe this accounts for the fact that no weapons or cartridges were captured.

- 4. We were unable to gain contact with the bandits again after the first action. Cleared Acuñas camp at 1300 and destroyed four small camps with a radious of half a mile from the main camp. Cleared for Jan Juan at 1900. Arrived San Juan at 1750.
- 5. Bandit casualties: five killed, 7 wounded. No Guardia casualties.

- 7. The Guardia employed two BARs, two STMGs, and Krag rifles. The bandits replied with one TSMG and Krag rifles.
- 8. The conduct of the Patrol was praiseworthy and deserving of commendation. Lieut Gutierrez was especially cool under fire and gave valuable assitance in controling the fire of the patrol.

15 July 1932, at about 2100.

PLACE OF CONTACT:

Guanacasco, on the main Esteli-Condega Trail, between Cascala (202-328) and Tular (203-327).

DURATION OF CONTACT:

The contact lasted about twenty minutes.

RESULTS OF THE CONTACT:

The most gratifying result of the contact was that the bandits were forced to expend quite a bit of their carefully hoarded ammunition. The death of their second Jefe, the wounding of their Teniente and the wounding of the others is bound to lower their morale. The loss of their bedding, clothes, toilet articles and mounts will also be keenly felt by them.

INCIDENTS OF THE FIGHT:

When we arrived withing 100 yards of the house we heard the bandits playing an accordion, singing and laughing. Several attempts were made to penetrate the heavy thorny underbrush but could not do so without using machetes. Upon discovering this I decided to concentrate my automatic weapons in the mouth of the trail we were on and concentrate their fire on the house. We were within five yards of the sentry and cound advance no farther without alrming the camp so I threw a hand grenade at the house and told the men to stand-by. The grenade hit near the sentry who watched for a second or two and then ran without saying a word. The signal to commence fire was given and the automatics and Thompsons opened up on the house and few bandits outside of the house.

Shortly after we opened fire the bandits returned our fire from their reten (see sketch) and forced us to withdraw about ten yards to a low place in the trail. From this point we gained fire superiority over the bandit reten and silenced them. About this time some of the Guardia riflemen from the main body had crashed their way through the brush and opened up on the bandits. The order to rush was given and the five automatic men and ten riflemen rushed the bandit firing line. We formed as skirmishers upon reaching the cleared place around the house and advanced on the stone wall the bandits were using as a trench. It was at this point the rifle grenades and dynamite bombs were used on us, wounding three of the men in the center of the line. The rush on the wall caused the bandits to disperse in all directions.

During the first minute of firing eight or ten bandits ran from the house directly into our line of fire. All five automatics were concentrated on them and all were knocked down, but got up again and staggered down the trail dragging one of their number. When they were opened up on they were no more than thirty yards away.

Some of the bandits crawled back through the brush and opened up on us again but were dispersed with a few bursts from the automatic weapons.


Raso Cardenas, Higuel #4073, is to be especially commended for his heroic conduct. After being seriously, if not fatally wounded, he remained on the firing line helping the others.

Cabo Narvaez, Hipolito #3892, is recommended for special mention for his coolness and the expert handling of his Browning automatic Rifle.

Señor Moises Gonzalez, hijo, is recommended to receive special letter of commendation from the Jefe Director for his desire to always help the Guardia Nacional. He was very cool and greatly assisted the Patrol Commander in line of fire. Señor Gonzalez is brilliant work at Daraili (where for his good work with the other accompanied. He was wounded once before while guidding a Marine Patrol that made contact.

NOTES:

From reports received from the people while trailing this group and from reports since received it has been clearly established that the group numbered from thir ty to thirty-five, armed as mentioned above. The Jefe was ZACARIAS PADILLA, Second Jefe CAPITAN ANTONIO RODRIGUEZ (killed), third Jefe Teniente Gregorio



(Gollo) Olivas. This group was known as "Columna numero ocho del Ejercito de los Defensores de la Soverania Nacional de la Republica de Nicaragua, bajo las ordenes del Coronel Zacarias Padilla".

Several people have reported that this group had been broken up into smaller groups by the contact and that some of these smaller groups were seen hunting animals next day to carry their wounded and heard to say that they had so many wounded that they wound not carry them all.

The patrol lived up to the highest traditions of the Guardia Nacional.

1. On the 24th of June, 1932, at 6:00 AM, 1 left by order of "El Consuelo" with 2nd Lieut Montes and 30 enlisted in persuit of a group of about 150 bandits under command of Pedron Altamirano going towards "El Sardinal" (283-309) where we arrived at 17:00 without any mishap.



On the 25th at 7:00 AM, we left the latter place and went towards "Tuma" (264-307), but after travelling a short distance I discovered traces of the bandits. I left the road going through the brush and came out at the road again a league and half further on, after having obtained information that the bandits were divided, that one group of about 60 was at "Agua Amarilla" and the rest behind the place where I had come out on the road again. I then ordered the men to spread in firing line along one side of the road waiting for the last group to pass, but instead of that the first group turned back and we had a contact with them that lasted five minutes, the bandits fleeing towards "Tuma" (264-307). No casualties on the side of the Guardia, one dead on the side of the bandits. Eight or ten bandits wounded, to judge by the trails of blood. Time at which the contact took place: 11:30 to We pursued the bandits as far as Agua Amarilla, 11:35. (281-302).

3. On the 26th we left for the camp of Navarro at 9:00 where I reported.

l. In compliance with the above mentioned orders, a combat patrol consisting of Lieut Snyder and twenty five enlisted cleared Yali at 0300, 15 July, for the scene of the contact the Condega patrol had with the armed group at Los Achotes, 14 July, 1932. The following is a daily record of events of this patrol:

15 JULY- Patrol cleared for Los Achotes via El Tigre, at 0300. Arrived at Los Achotes and the scene of the contact at about 0730. The bandits had laid their ambush having been laid in a comparatively open slope. The fire from the guardia arms had literally cut all the surpounding "monte" to pieces and many blood trails led back from the bandit's positions. Some of them had constructed fortified positions from stones and fallen logs. It is believed that the bandits later returned to the slope and carried away some of their empty cartridge cases, as there were few in evidence when the Yali patrol arrived there.

This patrol also found four newly made graves, these graves appearing to be large enough to hold from two to three bodies. The bandits had buried their dead late that afternoon or early during the night. It is believed that many of the wounded had died in the surrounding valleys, as plenty of "zopilotes" were in evidence, but due to the dense "monte" and the need for haste on the part of the patrol, no thorough search was made for these bodies.

Patrol cleared scene of the contact at 0830, proceeding in the direction of Los Portillos. All the natives in the vicinity had cleared out of their homes and knowing that it would be practically impossible to capture anyone in the immediate vicinity, who could give us information, I ordered the patrol to continue on in the direction of Los Portillos. The rains the previous night had obliterated all tracks on the trails, so I knew the patrol would have to circle the surrounding mountains in order to pick up any trail that the group had taken in leaving the district. All the houses in Los Portillos were uninhabited. Patrol continued on to Lower Pavona then swinging to the right to Upper Pavona. A through search of the mountains of this district failed to reveal a trail, and from there, we descended into the large Valley to the northwest. Patrol camped for the night on the Coyolar River, at a small place called Guachipolin.

16 JULY- Esteban Meza, owner of a small house situated on the Coyolar River at this point, informed me that, at about ten o'clock on the morning of the 14th, a group of about thirty, carrying eight wounded, passed his house proceeding in the direction of La Rica. This was the first information that the patrol had gained. Lieut Snyder did not follow on the trail of this group for the reason that he wanted to locate the trail of the large group. Believing that this larger group had taken a trail out somewhere between "Guachipolin" and "Los Terreros", the patrol continued on towards "El Arco", searching the small valleys and the ridges for signs of the trail that we were looking for. arrived "El Arco" at about 1400. Gained information there that a group had passed at 20014. The natives of "El Arco" could give no information as to the size of this group but stated that the day before the contact at "Los Achotes", a large group had passed in the direction of Los Achotes. arrived at Los Terreros at 1530, the Hacienda of one Vicente Ubeda, ex-Juez de Mesta; patrol camped for the night at "Los Terreros".

"Zancudal". At "Zancudal", learned that the day before the fight at "Los Achotes", a group of about one hundred had passed there in the morning and that the same group had returned by the same trail in the evening. This is the group that later joined up with Jefe Roblero at "Los Achotes". The jueces at "Zancudal" and Pavona failed to report these movements of the bandits to this office. The Yali patrol proceeded on to Yali via "San Carlos, "Las Guayavas", "Las Lajas", and "El Tule". Arrived Yali at 1530.

The only definite information this patrol gained was that Jefe Roblero came into "Los Achotes" via "La Pavona" and thru "Zancudal". Roblero was reported to

have had forty men under his direct command during the fight.

l. In accordance with reference I cleared San Rafael at 0300, 15 July, 1932, with a patrol consisting of myself, Lieut Muñoz, twenty four enlisted and one armed civico, to patrol area North and west of Santa Fe. The following is a daily record of events during this operation and those which I took part in afterward operating from Yali:

15 JULY- 0300 Cleared San Rafael for El Diamante arriving there at 0830. In El Diamante received information that a small group of bandits under the Jefe Captain Perez had passed there the day before going in the direction of Loma Azul, and as the patrol's orders were to go along this route I cleared immediately for "Las Lajas" and "long wil". In "Las Lajus", which is about one half league from "Loma Azul", the Juez de la Mesta reported all quiet and that there had been no bandits near there for over three months. Proceeded on to Loma azul. Upon our arrival the advance guard saw a group of bandits in and near the house of Duenaventura Sevilla. Upon our approach they fled into the brush. We then opened fire upon them and followed their trail which we lost due to their splitting up. Returned to the house of Sevilla and there received information that the Jefe od this group was unknown to them, but was called El Santo. Cleared the house of Sevilla for Loma Azul and arrived at thirteen hundred and made camp for the night.

16 JULY- 0600 Cleared "Loma Azul" for Cerro Azul and there received information that a group of about twenty bandits under the jefe captain Real and been there the day before and in the direction of San Antonio de Yali. at about 1200, 15 July, 1932, was the time given as the bandit's departure in this direction. Proceeded on to San Antonio and arrived there at ten hundred. The people of San Antonio said there had been no bandits there or near there for over a year. Cleared San Antonio on the Las Vegas trail. At Quebrada de Las Vegas found a trail to Pavona that had been recently used by about twenty five men within the last twenty four hours. Left the Las Vegas trail and followed the Pavona one and arrived on top of Pavona mountain where the tracks were following went off into the brush linglely. We then went over the top of Pavona and

formed a line and searched the underbrush finding a trail leading down the hill toward Pavona Abajo that was about one hour old. We followed this trail down into the valley and arrived at a group of three houses called "Soledad". Two of the houses were about two hundred yards apart and the other about five hundred yards away. The patrol was split and as there was brush all around the houses we were able to approach very near. Lieut Muñoz had eleven men with him and the rest of the patrol was with me. Upon me approaching closer to the house a woman yelled "run, here is the Guardia", and at this time we were fired on by about twenty men armed with rifles.

16 JULY- The Guardia returned the fire and Charged. The bandits ran into the brush on the other side of the house and took up a position and held it for about three minutes and then fled. They were followed for about one thousand yards to a camp of their's consisting of one house and five leantos. Evidence of at least one wounded was found in this camp. Various articles were found at this camp including correspondence, shotgun, ammunition and clothing. Patrol returned to the house and made camp at 1645. The hospital corpsman of the patrol reported to me that Reso Octavio Mejia had fallen and stuck a stick into his arm and that it was still in there and that Raso Julio Tellez had the mumps.

17 JULY- 0730 Cleared for Yali with the two sick men arriving there at 1230. Remained at Yali awaiting orders.

18 JULY- 0530 Cleared with a patrol under Lieut Weeks, leaving my patrol in Yali, and returned at 0240, 19 July, 1932. The events during this patrol is reported in Lieut Weeks patrol.

20 JULY- 1600 Cleared Yali for San Rafael by way of La Concordia with ten enlisted and one armed civico. Spent night in La Concordia and proceeded to San Rafael 21 July, 1932.
