## THE GUARDIA NEWS LETTER No. 121 (5 TO 14 OCTOBER 1932).

#### ----- 5 OCTOBER 1932 -000----

Lieut Stanko end patrol had contact at 197-358 night Oct 5, with a group of about 10 horse thieves under Jose Calderon. No Guardia casualties and no known bandit casualties. Recovered 2 animals stolen from Guardia corral. On return patrol next day all lost animals were recovered, 2 with saddles put on them by bandit group. At scene of contact were found 1 powder horn and primers and 1 hat with hat band. Believed bandits went toward Guzmajilla.

### -----000- 6 OCTOBER 1932 -000----

Lieut Ragsdale with ten enlisted returned Jalapa from patrol.

# -----000- 7 OCTOBER 1932 -000----

Captain Lakso, Lieut Sanchez with thirteen enlisted and fourteen auxiliared returned to Sauce from combat mission no able to across stream on account of high water.

Somotillo native reported group of 100, at point 136-306, night of 5 October, Somotillo investigating. Agent returned and reported 300 bandits in camp. Combat patrol of 16 enlisted and 8 auxiliares cleared Sonotillo. Lieuts atwell and Irtola, 16 enlisted, 8 auxiliares returned to Somotillo, report bandits had left 136-306 at 04007, going east. Lieut Atwell very ill and had to return.

Captain Lakso, Lieut Castrillo, six enlisted, thirteen auxiliared cleared El Sauce for Leon.

Lieut Gardner and eighteen Guardias cleared Managua via boat for Jan Francisco del Carnicero (205241) to operate on local information to the Northward of that place.

Group of thirty-five under Luis Herrera burned Hacienda La Viola (255-302).

Lieut Montenegro with patrol returned Jalapa.

Lieut Stanko with patrol returned Condega.

1st Sgto Portocarrero with patrol returned Pueblo Nuevo.

Lieut Price with patrol arrived Daraili.

Sgt Velasquez with eight enlisted cleared Ocotal for half-way to Macuelizo and Captain Yost and Lieut Aleman returned with patrol.

Captain Yost and Lieuts Aleman and Montenegro with five enlisted cleared Macuelizo for half-way to Ocotal. Fieut Montenegro with patrol returned Macuelizo.

Lieut Montenegro with ten enlisted cleared Jalapa for Entili.

Lieut Chavarria with seven enlisted cleared Dipilto for Ocotal. Arrived and returned.

Sgt Olivas with six enlisted and one prisoner cleared Yalaguina for Totogalpa. Arrived and patrol returned.

Lieuts Kipp and Bernheim with twelve enlisted cleared Ocotal for Mosonte and returned.

Sgto Peña with six enlisted and one prisoner cleared Totogalpa for Ocotal. Arrived and patrol returned.

Lieut Price with twenty-five enlisted cleared Condega for Daraili.

lst Sgto Portocarrero with ten enlisted cleared Pueblo Nuevo on patrol.

lst Sgto Cortez with six enlisted and two civicos cleared Condega on patrol.

Lieut Mamas and Lieut Guadra with twenty five enlisted cleared Jicaro for Apali. Arrived and Lieut mamas with sixteen enlisted cleared for Jicaro.

Lieut Bernheim with twenty five enlisted cleared Ocotal for apali via San Fernando. Arrived San Fernando and Lieuts Keller and Garcia with four enlisted joined patrol and cleared for and arrived Apali.

Lieut Adams with seven enlisted cleared Yalaguina for Somoto. Arrived and returned Yalaguina.

Lieuts Delgadillo and Aleman with ten enlisted cleared Totogalpa for half-way to Palacaguina. Lieut Delgadillo with seven enlisted returned.

Sgt Lopez with eight enlisted cleared Palacaguina for half-way to Totogalpa and Lieut Aleman with three enlisted joined patrol and returned to Palacaguina. Cleared for Condega. Arrived. Sgt Lopez with patrol returned to Palacaguina.

1st Sgt Cortez with patrol returned Condega.

Lieut Price with twenty five enlisted cleared for San Juan from Daraili but returned Daraili as could not cross Coco River.

Lieut Lopez with twenty five enlisted cleared Somoto on patrol to meet Lieut Berry and proceeded to 165-338).

1st Sgt Fortocarrero with eight enlisted cleared Pueblo Nuevo for Condega. Arrived and returned with six enlisted.

Limay combat patrol cleared Esteli for Limay, Lieuts McDonald and Barquero with twenty-seven enlisted.

Sgt Hatus with eleven enlisted cleared San Juan for half-way to Quilali.

Lieut Ragsdale with eighteen enlisted arrived Apali from Jalapa.

Lieut Beans with twenty enlisted arrived San Juan from quilali.

Native reports to runta Rieles that group of 100 jefe unknown crossed Railroad at San andres (168-284), robbed ranch and stated that they were going to attack runta Rieles.

1. In accordance with orders contained above reference the undersigned assumed Command of the Third District Combat Patrol which arrived Pueblo Nuevo at or about 20316 of the current month and prepared patrol for five days operations in area designated by above references. Two rasos were substituted for by two rasos from Guardia Nacional, Pueblo Nuevo, and five additional rasos were added to bring strength of patrol to two officers and thirty men and one civilian runner. The patrol complete and prepared for operations consisted of the below listed Officers and enlisted:

Above patrol cleared Pueblo Nuevo 23216 and headed directly for Naranja. Passed Limon (179-337) 24016 -Sabana (174-342) 01117 - Motolin (168-343) 02017.- no inforarrived Naranja, surrounded settlement 04417. Found one native in shack in south edge of settlement awake and fully dressed. He appeared very nervous and when questioned for information stated that large group in two bodies had passed Naranja (165-343) about 17016 proceeding from the North and following the main trail to the south. At this moment or at or about 04517 a tremendous burst of rifle, machine gun fire and grenades and dynamite bombs was heard in the direction, seemingly about one league to the south, that the native reported the bandits as heading. Having information that a patrol from Somoto under Lieut Sinkule with eighteen enlisted and Colonel Pichingo was also operating same area it was thought quite likely that this patrol had been ambushed as the first burst of fire was apparently from a fir ing line quite some distance in length and instantaneous. My patrol was reformed immediately and the Patrol Commander with the point consisting of ten enlisted, two STMGs, one Rifle Grenade Discharger, and rifles proceeded on the run for the direction Lieut Montenegro with the main body and of fire fight. animals following very closely beaind point. Heavy fir ing continued for about five to seven minutes and gradually subsided and ceased when the point of my patrol was about half way between Naranja and the location of ambush. moon was shining brightly and there was no difficulty in following the trail but unable to determine the positions of Guardia or bandits in ambush the point new proceeded at a walk being cautioned regularly that there were bandits just ahead but also there were more than likely Guardia and to be particularly careful. The trail up to this point followed the high ridge fairly regularly and on a level but as the ambush was approached the trail dipped down a steem incline. Just as daybreak arrived the point of my patrol had reached almost to the bottom of this ravine but we were still unable to locate the Guardia Patrol or Skirmish line. As the point was crossing the small stream in the ravine heavy rifle and BAR and STMG fire opened up again about two hundred yards to the front and above us. The point started on a run up the hill in front of us and heavy BAR and STMG fire was directed on the entire point. Luckily no one was hit and we took cover immediately and after a hasty reconnaissance of the terrain and direction of presumably the bandit fire we advanced firing. Lieutenant Sinkule's patrol had advanced up the steep ridge just to our right front and I gave orders to cease firing and advance on the double to reinforce his firing line. It later

developed that one large group, of from twenty to thirty bandits armed with one BaR and one STMG were occupying a small ridge about twenty yards from the main trail and about one hundred yards from the exact line of ambush and this group allowed me to pass with my point without firing a shot at us, evidently intending to allow us to advance further up the trail and enfilade us. The point reached Lieut Sinkules patrol and joined in the route of the group that was directly to his front scattering them in the valley. as Lieut montenegro with the main body advanced following the point, another group opened up on him from behind a stone wall that was at the crest of the ridge to his right front. He immediately formed a skirmish line and returned fire while advancing up the ridge. This group was scattered by the main body and as the main body reached the crest of the ridge, the group that occupied the small ridge to our right rear opened up with their BAR, STMG and rifles. Fire was poured into them immediately and the point had at this time been reformed and separeted from Lieut Sinkule's patrol and now returned to reinforce my main body. last fire fight was of about twenty minutes duration and we had to charge down thru an open corn field and up the ridge on the other side to disloage and scatter the group. It was in this last fight that the bandits suffered two of their dead, one of which was the Substitute Automatic Rifleman from whose body was captured the BAR Bandolier and five Magazines captured by my patrol. This group was finally dislodged and scattered, the majority of whom seemed to head to the south. The patrol was reformed immediately and having assisted Lieut Sinkules patrol to prepare the dead and wounded Guardia for the return trip to Somoto cleared immediately to the south and east in pursuit mission. The entire contact lasted from about 04517 (approximate time of ambush) until about 07217.

Lieut Sinkule and his entire patrol are to be especially commended for their aggresiveness and spirit in attacking a large group of bandits that had three strong and superior positions all of which were very much obscured by the heavy brush and undergrow h and to attack which the patrol had to advence thru, and up a very steep and rugged ridge. The patrol was ambushed on the rise in the trail of a small spur and the bandit firing line, evidenced by apparent firing positions discovered on a later reconnais. sance, was great in lenght and so placed that the bandits would have a perfect ambush laid for patrols approaching The first burst either from the north or from the south. of bandit fire was tremendous and was directed on the 30mo to Patrol from their right, front and rear. It is impossible to conceive under the conditions why or how more Guardia casualties were not sufferred in the first fire fight. Lieut Sinkules coolness and quick estimate of situation, development of resistance and attack and the entire patrol's alertness and obedience to control saved the day.

The Taird District Combat Patrol proceeded immediately after reorganization after the contact on following patrol in pursuit:

Cleared Sceme Contact 07417 - proceeded south to Chorro (165-338) no information. Proceeded North East to motolin (163-343) no information. Covered mountains between El Apante and Aguacate - no information. Arrived aguacate 12017 and had our first rest and chow since clearing Pueblo Nuevo. Cleared Aguacate (164-344) 14017 proceeded via Las Soleras (166-344) across pass in Somoto Mountain arrived pass 16017, examined all trails and brush paths, but no evidence of recent passage. Proceeded to Capules (173-344) via Santo Domingo (170-344) arrived Capules 17217, no information. Decided to spend night there as the patrol, even tho in good spirits and willing couldn't have gone much further. Had our first good chow in twenty four hours and a night's rest. Cleared Capules 05018 - proceeded to Naranja via Motolin. Arrived Naranja 08318 - no information. Proceeded to scene of contact. Found bodies of four dead bandits and several more hats and miscellaneous articles. No evidence of any of group having returned that vicinity. Cleared scene of contact 09313 and proceeded via Chorro to Pataste. Arrived Pataste 14018, no information. Remained Pataste until following morning having dispatched runner with patrol report, and request for orders and information, to Pueblo Nuevo. awaited return of runner following day until 09019 at which time he had not returned and information was received from reliable native that two small groups had passed Palmiro (168-337) day before heading toward S. Jose

(197-334). Cleared immediately for S. Jose via Palmiro and Sta Fe (176-337). No information either place. Returned back north to Sabanas. No information. Cleared for Pueblo Nuevo via Limon arriving Pueblo Nuevo 16319. No information. Dispatched reliable runner immediately for Capules and Motolin, thinking that if my movements had been watched that the groups might try a reconcentration and assembly and head south. Runner returned about 22319 reporting all quiet and no information.

The Patrol Commander wished to especially commend fieut Montenegro and the entire patrol of the Third District in these operations for their loyalty, obedience, and untireing energy over three days of rapid movement, with little rest and an average of one meal a day. There was never one instance of discontentor unwillingness to cooperate in évery detail. It was a decided pleasure to be on the trail with excellent fighters, a fast moving patrol, and good companions. The entire patrol lived up to the highest traditions of the Guardia Nacional.
