GUARDIA NEWS LETTER NO. 46- (30 APRIL - 9 MAY, 1931.)

(With delayed notes from the C.A.)

The following is a consolidated report of the results of the Guardias contacts with bandits during the month of April:

In the above contacts 20 bandits were killed, 17 wounded and 19 captures. The Guardia had 1 killed and 3 wounded. In addition to the above known number of killed and wounded bandits, many traces of others, either killed or wounded, were found at the scene of the contact but no estimate of these has been made.

In addition to the above captures, the Guardia captured various quantities of food, clothing, ammunition, equipment, etc. Several bandit camps also destroyed.

MISCELLANEOUS

The following extracts from the "Monthly Record of vents" for April 1931, for the Department of Chinandega, commanded by Captain E. A. Craig, G.N., are quoted:

POLICE OPERATIONS

No major crimes during the period covered. A fet small robberies have been committed in the country districts by groups of from two to six men; these groups are believed to be men out of work looking for food as most of the articles stolen were foodstuffs

They have not harmed the inhabitants during these robberies. Municipal police are now functioning in all the principal towns of this Department with the exception of Corinto; thir performance of duty todate has been very satisfactory.

INTELLIGENCE

State and territory occupied quiet with exception of the small robberies mentioned above. Groups mentioned have been armed mostly with cutachas and one or two old rifles or shot guns. Due to the large number of unemployed roaming in the Department at this time more trouble is expected from these groups of ladrones, as they must steal to eat. Active patrolling is being carried out to prevent the formation of any large group of the people mentioned.

MILITARY STTUATION

No armed group of any size or importance is believed to be in this Department at the present time.

ECONOMIC CONDITIONS

Prices of foodstuffs still unusually high. Prices of corn (7.00 frnega; beens from \$20.00 to \$21.00 frnega; rice \$6.50 a hundred pounds. For ge for livestock very scarce and high. Difficulty is being experienced in foreging the Guardia Nacional animals at 8¢ a day.

WEATHER

Clean and unusually hot. No rains.

ROADS AND TRAILS

In good conditions but dusty. Road to Puente Real and Cholute-ca, Honduras, getting in bad shape due to heavy automobile traffic and bull carts.

The following is a copy of a letter received by Major L.P. Hunt, G.N., Commanding the Northern Area, from Lieut. M. Welsz, G.N., Commanding the district of Santa Maria:

Santa Maria, Nueva Segovia, Nicaragua, 29 April 1931.

Dear Major Hunt:

These few lines will explain the economic and general situation of the Santa Maria District.

There is very little change in economic conditions praviously reported hoever, many Nicaraguans with their families have returned from Honduras to this District during this month and have settled down and are getting the fields ready for the planting season.

I have spread the word that, all men regardless of what the have been or being doing previously, are at liberty to return to this District and when they present themselves at these Head-quarters, they will be given papers authorizing them to live in this District or any place they may desire to do so, providing, they behave and abide to the Nicar guan Government and its laws. The result of this propaganda is, that many families have returned and cettled down in Coyolar, Aguacate, Occome and various places in this District.

The Sandinistas in Handuras are spreading propaganda and warning the people not to trust the Guardia, but to remain in Handuras because the help and amnesty that is being promissed them bynthe Guardia and their Yankee Jefes is nothing more than a trick to have them come over to Nicaragua and to kill them, but I carnestly believe that no propagands will stop them from returning to their country, as long as the Guardia will continue to carry out the policy adopted by this area.

The school in Santa Maria is progressing rapidly, we have two clases, one in the morning and one in the afternoon and both are fully attended by boys and girls ranging in age from 7 to 17 years.

I am trying to organize a school in Ococona, but so far was not able to find a suitable teacher, as soon as one is found, we will open up the chool thereat.

The civil functions are turned over to the newly appointed civil officials, who in turn are very proud of their appointments and are endeavoring to do everything to the best of their knowledge and ability, by coorating with the Guardia. Friday, April 1, 1931, they will meet and elect a Treasurer, {there is no money), also they will decide about building new municipal buildings large enough to house the Guardia (local) two rooms for the

school, one room for the officer of the District Commander and one room for the Alcaldia; the Jefes de Canton and the Jucces de Mesta will also be selected and popointed later on; considering all the district of Santa Maria is progressing slowly but stead-

Health of inhabitants and the Guardia is excellent, but the food is very scarce and the prices in Honduras (none obtainable in Santa Maria) are so high that it is impossible for these people to buy anything; it is believed that on account of Revolution in Honduras the next three or four months will be the hardest in the history of this district; in order to make the people feel better and to forget about their hunger and troubles, last Saturday 25th of April, the Guardia invited to a dinner all men, women and children from Santa Maria, Aguacate, Coyolar and vicinity which was attended approximately 150 persons (mostly women and children). After the dinner thee girls and thee guardias sked me for permission to let them dance, which was granted. The orchestra (Victrola) continiuosly played until midnight at which time all guests departed for their respective homes, happy and with, at least, one good meal under their skin. (the mal was prepared by the ladies).

The clothing for the school children is very badly needed, all they have on, was bought and paid for by Captain Holdahl; a little help from somewhere would be greatly approciated and it would help the Guardia to gain confidence of all Nicaraguan people, also it would knock the Sandinistas and their propaganda on the head.

At present there is no bandit activity in this District however, later on when more food will become available, it is believed that they will return to the Northerwestern Segovia, in the meantime the Guardia in this district should help the people out. It is believed that by doing so the Guardia will gain many friends, who will gladly inform them of any bandit movements and possible of their intentions.

If possible, I earnestly request that another officer be assigned for duty in this district, at present time and due to the shortage of food it is necessary for me to go to Ocotal (about 42 miles) after food supplies, during which time this post is left without an officer and sometimes without an noncommissioned officer; it would be no trouble whatever for bandits to capture this post with all machine guns and ammunition which is left ture this post with all machine guns and ammunition which is left the post during my absece, also for some dislocal guardia to take a machine gun and go to Honduras where he can sell it for a large sum of money. Two officers in this district can accomplish more than one.

Dear sir:

Enclosed are the two dollars for the Voctrola spring, Music means a lot to the Guardia and they cert inly appreciate it. We now have in town two Victrolas, half a dozen guitars, two reordions and one violin.

Six men arrived today from Suyatal, Nic., near El Horno and presented themselves. They tell me that several more will be in tomorrow. Suyatal is in the political jurisdiction of Macuelizo but in the military jurisdiction of Dipilto, but in accordance with the law the people must register their property here.

Eight houses are now occupied by civilians and they tell me that five more families will return in the coming week. The following is a list of the number of men who have presented themselves from the different Caserios:

Subject: Potrol report.

1. I cleared Leon at 10402 for Nigarote, arrived Nigarote at 12202. Cleared Nigarote for Tragaleguas at 13502 arrived Tragaleguas at 15002. Found that a group had murdered six men and wounded two women and one man. The dead are:

Gregorio Silva, mozo, working for the Leasume family.
Cirilo Lezama,
Marcial Lezama
Elias Lezama
Francisco Lezama, and
Arcadio Lezama.

The wounded are:

Ana Maria Corea de Lezama, Alfredo Corea, and Dolores Lezama de Corea.

- 2. The killing took place at about one o'clock in the morning on May 2nd, 1931. The group is estimated at about fifteen. They were armed with Krag rifles, 44 caliber pistols, 38 caliber pistols, 12 gauge shotguns and machetes.
- 3. The Lezama family has had a fued existing in the family and it seems that the Lezamaz who took part in the murder premeditated the murder and joined up with the group which happened along at an opportune time. The men recognized in the group are the following and were residents of the same vicinity:

Maximiliano Lezama, Gabriel Lezama, Exequiel Lopez, and Asuncion Lopez.

4. The fallowing named men from Nogarote are suspected by the residents of Nagarote:

Felipe Blanco, Marcelino Blanco, and Jorge Blanco.

5. I received information that the group had passed by way of Trinidad for Salinas. I cleared Tragaleguas at 16002 for La Trinidad and arrived at 17302. Searched La Trinidad and tried to get some information but could not get any. I cleared La Trinidad for Las Salinas at 18302 and arrived at 02003, searched the place and obtained information that the group has passed at 12002. Searched house of Felipe Blanco and found one double barrel shot-

gun but there were no people at the house. I returned to Negarote at 14003 and was informed that the group has passed Mateare sometime during the night. Later was informed that the group was in the vicinity of El Sauce, and headed for Matagalpa.

6. I cleared Nagarate at 03004 for Guanacastillo to search house of Jorge Blanco, arrived Guanacastillo at 04304, searched the place but found nothing. I cleared Guanacastillo for Nagarate at 05004 and arrived Nagarate at 06304. I cleared Nagarate for Leon at 08304, and arrived Leon at 10204.

- 2. On the morning of May 2, 1931 a telegram was received from the Alcalde of Nigarote saying seven people had been killed and two wounded at Trahaleguas, which place is about two leagues east of Nigarote.
- 3. Lieutenant Makus and five guardia were despatched to the scene by the train leaving Leon at ten thirty on May 2nd. He ascertained that six people were killed and three wounded and that the killing was the culmination of a fued existing in the Lezama family.
- 4. A thorough search was made of the countryside but none of the the group could be located. Latest information indicates that the group cleared for the North.

Subject: Patrol report.

- 1. A patrol consisting of myself, second lieutenant Leonard Curcey, and twenty enlisted Guardia cleared Puerto Cabezas at 0630 for reconnaissance of the Puerto Cabezas-Wwwa Boom Area.
- 2. The patrol searched each side of the railroa track from kilometer 11 to kilometer 26 for traces of bandits. It kilometer 19, where the railroad makes a sharp turn to the right, a position was found which indicated that a bandit group of about twenty men

had been in ambush there. Along the top of the bank to the left groves had been cut and outlined of prone men were found. Decayed food, eigarrettes butts, imprints of new nubber-soled and hob-nailed shoes, such as were included in the loots from the robbed commissaries were found at this place. A freshly cut trail through the adjacent brush indicated the route of approach and departure to and from this ambush. The barvous small Indian settlements along the railroad line were searched and found deserted, but no damaged appeared to have been done. At kilometer 21 a railroad bridge had been burned and traffic blocked thereby. At kilometer 26 a group of about 75 Indians refugees was met on the railroad track. These people had left Kipla, Plato, and other farms in the Vance District and were returning to their homes along the coast.

- 3. Indians at kilometer 24, who had come in from Myupini, Sissin and other towns to the North were questioned regarding bandit activities in those localities. Bandit groups had been in Ayupini and Sissin, but had left on the morning of April 14.
- 4. It is believed that the Puerto Cabezas-Wawa Boom area is free from bandits.

Subject: Patrol report.

- 1. In compliance with verbal orders received from the Department Commander at 1200 22 pril 1931 I left Puerto Cabezas with one officer, twenty five enlisted men and one civilian guide. The equipment other than the service rifles were three Browning putomatic Rifles and two Thompson sub-machine guns. The events of each day are set forth below:-
- 22 April Left Puerto Cabezas at 1430 by rail and arrived Moss Farm 2300. Detrained at Moss and proceed on foot to Louisiana where we procured three pick mules and a mule driver from the Standard Fruit Co. Arrived Logt which to 0230, 23 April and went into camps.

23 April - Left Logtown 0600 following railroad to Cuyutigne. Took trail to Lecus Creek. Arrived Lecus 1400. Left trail at Lecus and proceeded up Lecus Creek. At 1500 surprised and engaged a group of approximately twenty bandits. Four bandits were killed and three known to be wounded. Engagement lasted about five minutes. The remainder of bandits scattering in thick underbrush. One sack of Company stores (Blankets, shoes, etc.) and four guns were captured, one Winchester 22 caliber; one 16 gage breeck loader and two twelve guage muzzle loaders. The patrol then proceeded rapidly back into the Lecus Sacklin trail and advanced toward Sacklin. Went into camp on the trail six kilometers out from Lecus 1730.

24 April - Broke camp at 0700 and arrived Saklin 1300 same day. Only one Nicaraguan, Slate, and a few Indian families remained in town. Schlin had been completely sacked with the exception of one store owned and operated by Adolf Cockburn. The bandits group under comand of Abraham Rivera consisted of about forty five armed men and about sixty indians and boatmen. They arrived in Saklin Friday afternoon 17 April 1931 and left Saturday morning 18 April 1931, proceeding up river with eight large boats. The patrol spont night of 24 April in Saklin.

25 April - Three Indians returning down river reported that they had been used by Rivera as boatmen and that the Rivera group having met up with a few of the remaining men from the Blandon group had proceeded up the river, from Waspuk on Tuesday 21 April 31.7 with destination segovia. Left Saklin at 1230 and proceeded down the Wanks river by barge. At 1800 picked up small motor boat belonging to Mr. Lestor from the Cape. This boat has been used by the bandits in their trip up the river and left on the bank by them when it ran out of gasoline.

26 April - At 0130 camped on bank of river, six Rilometers below kum. 0600 embarked and proceeded down river. 0900 obtained service of motor boat at Jacinto Chow to tow barge. 2100 arrived Cape Gracias a Dios. Andres Boom and Sawa. In each place the bandits had cleaned out all food and serviceble clothing. The people were still much frightened and in fear of the bandits return.

27 April - In Cape Gracias.

T :

28 April - 0600 left Cape Gracias on Standard Fruit tug "North Star", left detachment one First Sgt. and six men and one B.A.R.; three weeks provisions at Cape. Arrived Puerto Cabezas 1600 hundered.

2. From reliable information received it is believed that the group encountered by the patrol is the one reported previous to have been operating around Ayupini and to the best of my knowledge was the last group remaining in this district. Informations gathered from several persons at the Cape indicate that the bandits under Rivera are endeavoring to reach Bucay and on the Coco River where they have directed a long house, between one hundred and fifty, and two hundred feet long, which will be used as their headquarters. It is believed that airplanes will can wipe this place out.

1. In accordance with the reference the following report is submitted:

ll Apr 31. 12:30 PM received report that Captain Harlen Pefley had been killed and Raso Manuel Morales had been wounded by bandits at Logtown. 1:45 PM patrol including myself, fifteen enlisted men and one civico, Mr. Beardsley cleared Puerto Cabezas for Logtown by train, arrived at Tigne Junction (Moss Farm) at 4:35 PM where four enlisted from Toledo Wye were waiting our arrival. Continued on Logtown with eleven enlisted and one civico by train, having eight men to follow by motor, car. Arrived Logtown 5:15 PM where Captain Pefley and patrol had contact, and where Captain Pefley was killed, searched all of Logtown and vicinity. Commissary house of the Overseer and food shed had been burned down. At 6:30 PM left Logtown with ten enlisted and one civico Mr. Beardsley for Cuyutigne, searched there and immediate vicinity, laid in ambush until 4:30 AM 12 April 31.

12 April 31. Left Cuyutigne at 5:15 AM arrived Logtown at 6:00 AM Researched Logtown 6:45 AM left Logtown arrived Louisiana Farm where we found the balance of the Guardia patrol awaiting us. We were notified that one half hour after our patrol left Moss Farm by train and motor car, that bandits attacked there, killing eight men, four of which were americans, two were commissary men, and two unknown. There were other bodies scattered between Moss Farm and Louisiana Farm. 8:15 AM left Louisiana Farm for Moss Farm where bandits were still in force 8:30 AM had contact with bandits forcing them to retire. Raso Pascual Rivera wounded twice, one shot entering left side of nose passing and tearing out the right eye, other entered right shoulder lodging in his body. At the time the bandit casualties were unknown but later reports were, that four were killed. Road before and behind us was blocked, also telephone lines had been cut. Tried to send report into Fort by motor car running along, but plan did not work as the Snaki bridge had been tampered with. Two amphibian planes arrived about 11:30 . AM bombed at Vacarro Farm, and in the woods where it was latter learned that bandits had been hiding. 11.40 AM patrol including myself, thirteen enlisted and Mr. Beardsley cleared for Vacarro and Dantoni Farms, arriving Dantoni at 1.30, enroute searched vacarro and vicinity, also vicinity of D'antoni. At Vacarro Form the bandits burned the Commissary, the mandador's house and three other houses belong to the laborers. Arrived Moss Form at 3:00 PM. Mr. Augustin Murphy and one colored man arrived and notified me that five hundred (500) more bandits under Pedron were enroute from the Banks River and intended to take Puerto Cabezas. 3.30 PM left Moss Farm with intentions of cutting off bandits at Wakiwas. Had contact with bandits while trying to cross Snaki Bridge where rails had been torn up. While Mr. Beardsley with a detail of Guardia repaired the rails, a detail under me held the bandits in check and forced them to retreat. No casualties among Guardia, while repairing rails on the far side of the bridge two planes arrived and made a drop, wanting to know where they could drop provisions and ammunition. Did not have time to answer but made signals toward Wakawas. 4.30 FM arrived Wakiwas, received rumor

there that bandits numbering five (500) hundred under Pedron were coming through to Port burning and robbing on the way in. Intended to kill all machos, (Americans). In Wakiwas we met Sot Taylor with eleven guardia one applicant and one civico as re-inforcements. Made Camp at Wakiwas making tatical preparations for a defense. 7:00 PM in telephone communication with Guardia Headuarters in Puerto Cabezas, explained the situation and asked for food and ammunition. 9:00 AM received code message from Coptain Wood, that h would arrive about 6:00 AM 13 April 31, with re-inforcements, food and ammunition, and for my detail to be prepared to move forward immediately upon his arrival.

13 April 31 - 5:20 AM. Captain Wood, Lieutenant Simmer and six enlisted men arrived. Captain Wood immediately taking charge of the entire patrol.

The following items are extracts from the "MCNTHLY RECORD OF EVENTS" of the Department of Leon, commanded by Major J.W. Webb, G.N., for the month of April, 1981.:

GENERAL POLICE CONDITIONS

Police conditions have been unusually good during the month. Due to the excitement and the number of refugees in Leon from Managua, curfew law was established, curfew being at 10:00 pm. in an effort to curb robberies at night. Curfew was maintained for a week and gave wonderful results. The people worked very well with the police in maintaining order and very few complaints were received.

INTELLIGENCE

General state of territory occupied: Few rumors of band being organized in Las Mercedes area, near quezalguaque. Otherwise quiet.

MILITARY SITUATION

There are no organized bandits, but from rumors it is reported that Daniel Gomez, murderer and fugitive from justice, is trying to reorganize the Coto Diaz gang in the vicinity of Las Mercedes. It is reported that he has ten men gathering in that vicinity, but to date he has made no raids.

ECCNOMIC SITUATION_

Foodstuffs have increased in price, and due to necessity of sending food to Managua by the Red Cross of Leon, all of the surplus food stuffs have been expended. Corn and beans are scarce.

MISCELLANEOUS

The city of Leon responded to the call for aid for the injured and refugees of Managua. A red cross unit was formed and work begun to gather food stuffs and medicines to be sent to Managua. Within seven hours after having received notice of the earthquake

the Rad Cross was formed and a car load of supplies was under way for Managua together with medicines and civilian doctors. The city received the refugees, and the people together with the Red Cross received and care for about three thous and refugees. In addition, other supplies were cent to Managua.

The following are extracts from the "MONTHLY RECORD OF EVENTS" for April 1961, from the Department of Rives, commanded by Captain E. E. Larson, G.N.:

MILITARY OPERATIONS

District of Rivas: The District of Rivas was thoroughly patrolled by the Department Commander and the patrol officer during the month. Regular weekly inspection trips made to San Juan del Sur, San Jorge, Buenos Aires, and Potosi. Guardia and quarters inspected and civil officials interviewed. Pay guard furnished R.R. paymaster on pay days. Guardia supervised the food distribution and kept order among the refugees from the Managua earthouake..

District of Cardenas: Station of Cardenas taken over by Lieut. F. Bollo on 25 April. During month regular patrols made to Rivas, Sepoa, Sebalos, Orosi and surrounding cattle farms. Area quiet, no disorders of any kind. Aegular inspections made by the Department Commander or patrol officer at least twice monthly.

GENERAL POLICE CONDITIONS.

No serious crimes committed in the Department during the past month. Comparatively little police activity. Sile of Aguardiente has fallen off sharply, resulting in fewer cases of drunks confined.

ECONOMIC CONDITIONS

Economic conditions very bad. Several wealthy cattle owners have been embarged or presented themselves for bankruptcy during month, causing a general loss to creditors throughout the Department. Business is slow. Prices set by Jefe Politico's decree:
