

GUARDIA NEWS LETTER NO. 50 - (28 MAY - 5 JUNE 1951)

28 MAY 1951



Lieut. Stanko and Pataste (NA) guardia patrol returned to Pataste from southwestern Segovia. Confiscated one revolver and one rifle.

NOTES FROM CENTRAL de POLICIA, MANAGUA.

Ten of the twelve men who enlisted from the Policia Urbana in the Guardia have been discharged to again form the City Police, since the Distrito Nacional has authorized the enlistment of ten members for duty in Managua. The other two men wish to continue their service as regular Guardia. The organization of this force again is a source of pleasure, as the men so selected are Guardia with excellent discharges and make fine policemen. It is hoped that we will soon have our former strength again.

Petty robberies and traffic are the sources of all the worries of the Police at this time. Many people find it easier to steal than to work for a living. The arrests have reached such a number that it will soon be necessary to open an annex to hold the overflow.

Building in the city is going forward very rapidly and it will not be long until the unburned parts are the same as before the earthquake. The business section has shifted principally to the eastern part of town and second street south has become the Broadway of Managua.

Lieut. Long, U.S., has been temporarily detached for duty in Granada while the medical officer on duty there is on leave.

Lieut. Jack Davis has been on the sick list for a few days but is now back to duty. He intends to take leave shortly in Panama and expects to make the trip in a plane.

Captain H.H.H. Fleming, Chief of Police, reports economic conditions returning to normal.

In the above contacts 25 bandits were killed and 11 wounded, the Guardia had one (1) wounded. In addition to the above known number of killed and wounded bandits, many traces of others, either killed or wounded, were found at the scene of the contact but no estimate of these has been made.

In addition to the above captures, the Guardia captured various quantities of food, clothing, ammunition, equipment, etc., several bandit camps also destroyed.

The citations were delivered by the President on June 1, 1931, and the medals forwarded to the Nicaraguan Minister in Washington for delivery through the State Department and the heads of the respective services.

On June 1, 1931, in the Chapel of the Christian Brothers building in Managua, the Military Academy of Nicaragua held its graduating exercises. Twenty eight students received diplomas and graduating certificates and commissioned. The President of the Republic delivered the commissions, followed by a few remarks. Other appropriate ceremonies followed. The Cadets who graduated and are now second lieutenants in the Guardia, will be assigned stations after returning from short leave.

Colonel J. C. Smith, Commanding the Central Area, reports the following:

" With the approval of the Area Commander, the Jefe Politico of Jinotega appointed the following committee to take charge of and distribute the food supplies received from the American Red Cross:

Senior Andres Rosales, Alcalde of Jinotega,  
Senior Pedro Lopez, Liberal.  
Senior Pedro Palma, Conservative,  
Lieut. Wm. A. Lee, Guardia Nacional.

This committee worked under the supervision of Captain Max Cox, G.N., Commanding the District of Jinotega.

One hundred bags (10,000 pounds) of beans and twenty five bags (4,125 pounds) of corn received by the committee and allotted to the four towns in this department as follows:

Yali	20 bags beans	6 bags corn
San Rafael	15 bags beans	3 bags corn
La Concordia	14 bags beans	5 bags corn
Jinotega	51 bags beans	11 bags corn.

The committee with the aid of a few enlisted guardia, distributed the supplies allotted to Jinotega to about six hundred needy families. The committee passed on each family that received a donation. The distribution covered a period of five days. Each family received about ten (10) pounds of foodstuff.

The supplies for San Rafael, Yali and La Concordia have been forwarded to the Alcalde of these towns. Report of distribution in these towns at a later date.

The following are extracts from the "MONTHLY RECORD OF EVENTS" for the Department of Chinandega, commanded by Captain E. A. Craig, G.N., for May, 1931:

POLICE CONDITIONS: Very good. Only two major crimes during the month; one of which was the robbery of a watch and a small amount of money from a German citizen stopping at a local hotel, and the other the killing of a native by another near Posoltega. The murderer was captured and is being tried at the present time. Municipal police have been organized and are functioning in Corinto, in addition to the towns mentioned in previous reports.

INTELLIGENCE: State of territory occupied quite. Active patrolling has been carried out during the past month with the result that the small groups of ladrones mentioned in last report have been unable to operate and no robberies nor assaults on fincas have been reported. It has been ascertained that many of the ladrones, who have been causing troubles, came from the city of Chinandega and would return there after committing robberies. The plan of blocking all roads in and out of Chinandega two or three times a week with all available guardias and police was put into effect with excellent results. This was in addition to the regular patrols in the country, and in this way it has been possible to pick up a number of wanted criminals and ladrones in addition to some arms and make it very risky for the bad element to operate.

MILITARY SITUATION: No armed group of any size or importance is believed to be in this department at the present time.

ECONOMIC CONDITIONS: There has been no change in the prices of <sup>new</sup> staple <sup>local</sup> foodstuffs in the various towns. Due to the rains there is now plenty of fodder for the animals.

RELATIONS OF GUARDIA AND CIVIL POPULATION: There has been no friction between the Guardia and the civil population. Present attitude towards the Guardia favorable in local papers. The newspaper "Don Quijote", which was anti-Sandinista and very pro Guardia, has had to suspend operations as the editor was arrested on many complaints most of which appeared to be trumped up, and at the present time he has been banished to Leon where he is serving a sentence of 90 days given him by the Local Director of Police. This would make it appear that some people in Chinandega are against any favorable propaganda for the Guardia and resent any adverse comments against Sandino.

POLITICAL SITUATION: Normal. Campaigns for the election of new Alcaldes in the various towns are being carried out, but so far have not created any unusual excitement. Some few improvements in public works have been noticed in some of the towns; these were initiated by the local alcaldes to impress the people and gain reelection.

WEATHER: Warm and sultry. Heavy rains each day.

ROADS AND TRAILS: Getting in bad condition. Automobiles can travel only on the Chinandega-El Viejo road. All automobile traffic with Honduras has stopped and the trip to Choluteca now requires some twenty four hours or more, depending on the condition of the rivers at the different crossings. Most people travelling from Honduras and Salvador now go by gasoline launch from Amapala or La Union to El Tempisque which is eighteen miles by a bad road from Chinandega.

The following are extracts from the MONTHLY RECORD OF EVENTS from the Department of Rivas, commanded by Captain E.E. Larson, G.N., for the month of May, 1931:

DISTRICT OF RIVAS: Regular weekly patrols made by the Department Commander and the patrol officer during the month. Guardia and civil officials in San Juan del Sur, San Jorge, Potosi and Buenos Aires visited weekly. Guardia pay guards furnished R.R. paymaster on pay days. Guardia at all out stations made regular weekly patrols to nearby villages and haciendas. Guardia patrol furnished Lt Talley, USA from Rivas May 8 to 11, on patrol covering Tola, Las Salinas, Brito, San Juan, El Ostial and Naranjo. Area quiet.

DISTRICT OF CARDENAS: Guardia in Cardenas under command of Lieut. Bello very active. Made patrols twice a week along border from Sapoa to Rio Pizote. All surrounding cattle fincas visited. Area quiet. Regular inspections made by Department Commander for pay purposes.

ECONOMIC CONDITIONS: Still bad, but with the start of heavy rains on May 12 conditions are picking up.

ROADS AND TRAILS: Have become impassable for automobile traffic. Rivas-San Juan del Sur and Rivas-Potosi-Belen-Ochomogo roads already in bad shape. Lake trail to Cardenas still in good shape.

The following patrol report of Lieut. Broderick, G.N., is quoted:

Guardia Nacional de Nicaragua, Macuelizo, Nueva Segovia,  
29 May 1931.

From: Commanding Officer.  
To : Area Commander, Northern Area.  
Subject: Patrol Report.

1. I cleared Macuelizo at 16327 with a patrol consisting of myself and ten enlisted. We proceeded to Portilla Palmas, 165-366, arriving at 1830 and laid in ambush along the eastern side of trail. It began to rain at 2000 and rained until 08028.

2. At 04028 patrol cleared Portilla Palmas and proceeded to 166.5-362.5, where an attempt was made to cross the Rio Coco. The Rio Coco was full from bank to bank and flowing swiftly. I left my arms and equipment on the north bank and attempted to swim it with my horse but failed. Only three members of my patrol could swim and we did not have enough rope to stretch a line from bank to bank, so I decided not to attempt the crossing because of the danger to the lives of the men and the danger of losing weapons, specially the rifle grenade outfit and the TSMG.

3. We then proceeded to the house of Rosendo Padilla and searched it (166-362), finding a pair of Guardia shoes and some mess gear, which we confiscated. Padilla began sounding off about being the son of Deputado Padilla and having more rights than the average citizens. I have been told by several people that the bandits pass Padillas' house frequently and that he does not report their passing. He sleeps in his house every night in an area where the bandits kill all honorable citizens they can lay hands on.

4. The patrol then proceeded to San Luis 164-5-361, arriving at 09028. The people here reported no recent bandit activities and advise us against attempting to cross the Coco, saying that it would be at least thirty-six hours before the river would lower enough to allow crossing.

5. We then proceeded down the north bank to Los Limas, 167-363, where Juez Tercero of Sonoto has an hacienda. His son Francisco and one mozo were working and advised us not to try crossing the river. We did not get to San Diego because the formation of land and the twistings of the river makes it necessary to cross it three times. We then patrolled the bank of the river and the pastures north of it until 15028, and not having heard firing from the other side, and being sure that the other patrols could cover the remainder of the triangle in three hours, we proceeded to Macuelizo, via Portilla Palmas, La Mesa, Ocote Seco and Recuerdo, arriving at 18328.

2. Patrol cleared at 0300 and arrived at vicinity of bandit camp about 1030. Split patrol and ordered Cabo Ponce to take eight men and approach camp from flank. Cabo managed his eight men skillfully, maneuvered into a good position and opened fire, the bandits returning the fire. Firing lasted about five minutes.

3. Casualties: Bandits - 5 dead, number wounded unknown.

Guardia: No casualties.

4. Camp was located on a spur leading from a large hill. Camp consisted of three houses. Houses contained red flags, black ribbons, drum, machetes, , small quantity of ammunition, sleeping mats and cooking utensils.

1. On 24 May 1931 at 5:00 pm. upon receipt of reliable information that a group of fifty (50) bandits were robbing the people of Guayacali I cleared immediately with the following sixteen guardia and one civilian:

Taking the trail toward Santula which is a favorite bandit trail.

2. Arriving at Cacaala at 2300. Camped overnight. Obtained information bandits at Santula.

3. Cleared Cacaala at 0500 and arrived at Santula at 1000. Bandits had robbed many houses and had left in two groups toward Rodco. Followed bandits to Rodco where many natives verified the first information. Complaining about being robbed by a group of about fifty led by a man named Rivera.

4. Follow fresh trail for about ten hours leading through heavy woods and extensive potreros located on Miraflores mountain, gained contact at fourfifteen pm. at La Colmena, near Concepcion, Jinotega.

5. Bandits discovered, located on a high thickly wooded mountain top, near the house of Luisa Rodriguez at La Colmena. Upon approach of the point of the patrol the bandits opened fire. Apparently the rear guard of the Rivas group. The patrol was immediately deployed and fire directed upon the bandit position, using all the weapons available which was answered by the whole bandit group with rifles and one TSM and Lewis machine gun. Their fire was well directed and distributed toward our position. Our advance being held up for nearly ten minutes. Eleven rifle grenades were fired toward the bandit machine gun positions which were located on the top of the mountain well hidden behind a big tree and a heavy log. Five of the rifle grenades of the eleven fired exploded and silenced the machine gun fire. (Six rifle grenades were duds).

Patrol changed position under continue heavy rifle fire and after thirty-five minutes fighting with a determined rush the bandits were driven from their stronghold toward the direction of Volcan mountain located near Concordia. Bandits fled in every direction in scattered small groups apparently collecting again and proceeding in the direction of Volcan Mountain. They left two dead and took with them about eight wounded.

6. Captured: Rifle 1 Con-Con  
Small amount of ammunition  
Four animals.  
Three capotes.  
Food supplies, hats, hot bands and other miscellaneous articles.

7. The whole patrol endured the heavy marching in excellent and cheerful manner and fought persistently with great enthusiasm bravely to the end. Viva Guardia Nacional was heard from every member of the patrol from the beginning to the end of this short engagement.

8. Returned to Condega at 1400 on 26 May, 1931 via near Yali, Joeste, San Luis and San Diego..

The following letter received by Colonel L. A. Hunt, G.H., Commanding the Northern Area from Lieut. J. Hamas, G.N., Commanding the District of Condega:

CONDEGA., NIC., 31 May 1931.

My dear Colonel:

Knowing that the Colonel is very much interested in the pacification progress made by each District Commander I have the following to report:

The Guardia of Condega, through good behaviour and work, have gained the full confidence of the people. At any time a patrol is to be sent out to pursue bandits there are always plenty of men who voluntarily report to me to help the post.

Notwithstanding the bad economical conditions, Condega and the other smaller settlements are boasting new homes, built under the protection of the Guardia.

Cususa almost eliminated. Extensive fields well cultivated and there is a strong sign of prospective progress which will lessen the misery and hunger now felt by the poor.

Banditry is kept well down and the people are moving about freely everywhere.

Ever since your approval to enlist a Cabo school teacher, the illiterate guardians are learning to read and write. The same teacher gives free instruction to the boys of the town. Girls' school is kept up by parents who employ a teacher paid a moderate sum by small contributions each month.

I have under cultivation a little piece of land for raising vegetables and to cultivate enough plants to donate to the poor also. The school boys are taught once each week in the art of cultivation. This will help them in the future.

Fruit trees: mangoes, oranges, etc. planted and still planting more in the grounds of the Plaza to give the town a better appearance in the future.

Sick and hungry citizens of town helped as much as we can. On the other hand, we have our difficulties also, food supplies running very low, but we trust the future crop which apparently will be very good.

Subject: Patrol report of May 18th and 23rd, 1951.

1. In obedience to verbal orders received, cleared this post on the morning of the 18th, and returned in the afternoon of the 23rd.
2. Personnel of patrol, 2nd Lieut. W. E. McGhee and fifteen enlisted.
3. The object of the patrol was to find and destroy a group of bandits reported as moving north of San Antonio towards La Virgen. Information furnished by Captain Tower's patrol of the 14th. My object was to enter this area from the North.

April 18 - 0730 Cleared Corinto Finca.  
1640 Arrived Los Cedros, patrol route as follows:  
Embeceaderos. No information.

April 19 - 0700 Cleared Los Cedros north towards Guapinol area.  
Found two bandit camps about a league north east  
of Los Cedros. Had appearance of having been recently abandoned.  
Houses, numbering nine in all, were destroyed. No trails leading  
of this camp, only the one entering from the main trail.

April 20 - In Guapinol area.

Followed numerous trails that crossed the main trail  
north on this date. Found one small camp of three houses one of  
them a large one, contained three native saddles, small amount  
of medicine, one cutacha, two aparejos, and small amount of corn  
and rice. Various cooking utensils and a native outfit for the  
making of tortillas. Not having sufficient pack animals to take  
away the above listed articles they were destroyed along with the  
houses. It is my belief that this place was a sort of a message  
center, its equipment used for carrying food to the larger bandit  
camps.

April 21 - 1700 Arrived San Antonio. Patrol route as follows:  
Guapinol area and La Virgen.

About an hour and a half after breaking camp,  
found a small trail into the brush which led to a small camp of  
three lean-to that seemed to have been used only one night.  
They were built for three or four men each. In the trail to this  
camp was found the enclosed letter signed by Pedro Irias to a  
Captain Vallesio. Judged this letter to have been lost by the  
above mentioned bandit Captain during his trip south for food.  
Apparently this group had passed only a few hours before the  
letter was found. For it had rained steadily most of the night  
and the paper was only slightly damp. The surrounding ground  
was searched thoroughly for the next three hours, but was unable  
to pick up any new trail. Later in the day picked up a new trail  
just north of La Virgen. Looked as if ten or fifteen men with  
possibly four animals had passed there headed south. Passed the  
scene of the bandit camp, on the San Antonio-Los Angeles trail,  
that was destroyed by a patrol under Captain Tower on the 12th  
of this month. Two new lean-to had been built since the original  
camp was destroyed. The new structures were lightly built and it  
was quite obvious that were only in use for a short time. The  
trail from this camp led to a corn field behind the house of  
Gregorio Gutierrez. This man was captured by a patrol under  
Lt Withers on the 13th of March, after having admitted that he  
came into Jinotega and returned to his house with food and shoes  
for Peralta who was camped near his house in December 1930. At  
present this man is out on bond.

April 22 - Cleared San Antonio 0700. Arrived Sajonia, patrol  
route as follows: Tuma, La Colonia, Santa Isabel, La Union and  
Zapotlan. No information.

April 23 - Cleared Sajonia 0800. Arrived Corinto Finca 1240.  
Patrol route as follows: Quebrada Honda and La Trampa. Arrived at  
Corinto Finca without further incident.

The following report covers the contact of Lieut. S. H. Ragsdale, G.W., and El Garrion (La Lineda) guardia with a bandit group in the attempted attack on the Guardia garrison on 2 May 1931:

1. The following is an account of a demonstration by armed enemy forces against the Guardia garrison at El Garrion, Department of Matagalpa, Nicaragua, and an engagement resulting thereby.

2. At 2130 on the night of 2 May 1931, the Guardia sentry on post #1 at the El Garrion barracks discovered three armed men about twenty yards away crawling towards him through the brush. Receiving no answer to his challenge the sentry opened fire upon the men who leaped forward out of the brush. At this moment the other eight guardia in garrison went into position and opened fire, opposing some ten or twelve riflemen who appeared for a moment at the edge of the brush, turned and ran. Firing had lasted about one and one-half minutes. The Guardia had expended thirty rounds of rifle ammunition, and the bandits about ten or fifteen.

3. I ordered cease firing as soon as the bandits disappeared into the brush, and with two guardia charged their flank and pursued, leaving seven men to hold the barracks. We followed five fleeing men at a hard pace for about four hundred yards, firing but drawing no return fire. (Natives assert that at this time some ten or twelve men opened fire upon us from a position some six hundred yards to our right flank, but if true we did not notice it during the hard chase and other firing). One of the men we were pursuing fell wounded near the edge of a deep ravine, as witnessed by both Guardia, but we were unable to secure his body. The bandits scattered and escaped down several coulees. We gave up the pursuit and returned to barracks. I found that there were no Guardia casualties, checked ammunition and cleared with two enlisted on reconnaissance, but could find no indications of a bandit group or encampment and after a three hour search returned again to barracks.

4. Guardia Casualties: None.  
Bandit Casualties: One wounded, believed dead.

Following articles were captured: one (1) machete, one (1) hand bomb, eight (8) rounds Springfield rifle ammunition, U.S. cal. 30.  
Note: Seven rounds of the ammunition captured was of mark F.A. 27, and one round was of mark U.S.C.C. 18. All was "dumdummed", marked by slicing off part of the point.

The conduct and discipline of all Guardia was excellent.

C. It is the officer's belief that the group engaged was merely a small group of some eighteen or twenty local bad characters, who did not intend to engage in a fire fight, but who intended attempting to murder the sentry and stealing the arms of the sleeping Guardia.
