<u>51 JULI 1951</u>

Lieut Zepeda and Matigmas (CL) guardia patrol had contact with a group of two hundred bandits under Altanirano and Irias at Carrizal near Saiz at 3.00 p.m. The fight lasted 20 minutes. No guardia casualties. Bandit casualties Unknown. The guardir captured 4 machetes, 8 horses and mules, provisions, shows, trousers, shirts, blankets, harmocks, hats with red and black bands, field scarfs, a watch, a looking glass and one sack containing lead balls used for making bombs. Bandits headed north towards Tuna River. This was the group that attacked Santo Domingo and headed north. Most of the captured material is part of the articles taken from the village of Santo Domingo.

- 1 Lieut. Tercero and Juigalpa guardia patrol cleared for Acoyapa; patrol arrived. Nothing to report.
- 2 Leitt. Tercero and guardia cleared Acoyapa for San Pedro and Javali; arrived Santo Domingo. Lieut. Krebs cleared Juigalpa for and arrived Comalapa.
- 3 Lieut. Krebs and patrol returned to Juigalpa from Comalapa. Lieut. Tercero and patrol cleared Santo Domingo for La Libertad. Arrived and cleared for Juigalpa.

- 17 Boaco guardia patrol to Teustepe to investigate shooting in that place. Camoapa guardia to Juigalpa with seven prisoners. Juigalpa guardia patrol to Acoyapa on police mission. Lieut. Bell and guardia patrol arrived Juigalpa from Managua. Lieut. Bell and guardia patrol cleared Juigalpa for La Libertad with orders to proceed to Santo Domingo, to investigate report from Javali that bandits had been seen about 15 miles from that place.
- 18 Juigalpa guardia patrol cleared Juigalpa for La Libertad and Santo Domingo. Santo Domingo sacked by a group of three hundred. This patrol cleared La Libertad for Santo Domingo.
- 19 Lieut. Bell and combat patrol cleared La Libertad for Santo Domingo and arrived. Lieut. Tercero and combat patrol cleared Juigalpa to reenforce La Libertad. The Juigalpa patrol under the first sergeant had a contact with Pedron's rear guard, killing three bandits, then combined with the four guardias from Javali Mines for operations against the bandit force. Followed them, but were unable to regain contact.
- 20 Guardia patrol cleared Juigalpa for La Libertad to strengthen that garrison. Lieut. Kipp, Lieut. Sandino and guardia detachment arrived Juigalpa from Managua for temporary field duty. Lieut. Bell and combat patrol, operating in vicinity of Santo Domingo, had a skirmish with bandits, but not known casualties.
- 21 Lieut. Bell and combat patrol cleared Santo Domingo for Betulia on combat mission pursuing bandit groups. Lieut. Kipp and combat patrol cleared Juigalpa to operate vicinity of La Libertad.
- 22 Lieut. Bell and patrol operating north of Betulia. Lieut. Kipps patrol arrived Santo Domingo. Santo Domingo reported several shots fired during the night. Bandit captured with two plane panels. Two patrols at work from La Libertad and Santo Domingo repairing telegraph line. Necessary to use barbed wire as bandits had carried away most of the telegraph line.
- 23 Lieut. Bell, Lieut. Kipp and patrols operating Rio Grande area. Lieut. Tercero and patrol operating north of La Libertad.
- 24 Lieut. Bell, Lieut. Kipp, Lieut. Tercero, Lieut. Sandino and patrols operating in the mountains north of La Libertad and towards Camoapa.
- 25 Lieut. Bell, Lieut. Kipp, Lieut. Tercero, Lieut. Sandino and their patrols operating La Libertad and Santo Domingo area. Lieut. Kipp's patrol arrived Santo Domingo. Lieut. Bell's patrol returned to La Libertad.

- 30 Captain Griffin, Lieut. Lee and Central area patrol cleared San Jose for Boaco. Captain Small, Lieut. Atha and Central Area guardia patrol cleared Boaco for Tierra Azul. Lieut. Krebs, Lieut. Tercero and patrols cleared Camoapa for Boaco.

GENERAL STATE OF TERRITORY OCCUPIED: At this time, infested with Pedron group, consisting of about three hundred well armed bandits.

MILITARY SITUATION: Patrols are scattered from Santo Domingo, La Libertad, Camoapa, Boaco to Tierra Azul, making a determined attempt to get contact with the Pedron group. Six patrols are now operating in this Department and are actually in the field. Pedron has demoralized this department somewhat, but the situation is well in hand and contact should be gained.

ECONOMIC SITUATION: Very bad.

POLITICAL SITUATION: Quiet: nothing to report.

FRICTION BETWEEN GUARDIA .ND CIVILIANS: None.

WEATHER: Heavy rains night and day.

ROADS AND TRAILS: Very bad, muddy and traveling is slow.

Captain F. M. Howard, Department Commander, reports that the Municipal guardia received instruction daily with the Guardia and are regularly inspected. The Jueces de Mesta and Canton continue to perform their duties in a very satisfactory manner and are a great aid to the Guardia Nacional. Duty has been very hard and trying to all concerned during the last part of the month and station duty was performed by the Municipal Guardia, to release more guardias for field duty.

There is quoted below the patrol and contact report of Captain O. A. Inman, Lieut. T. M. Stephenson, Lieut. J. Montenegro and Puerto Cabezas (EA) guardia patrol, during July 1951:

DEPARTMENT OF NORTHERN BLUEFIELDS GUARDIA NACIONAL DE NICARAGUA PUERTO CABEZAS, NICARAGUA 21 JULY 1931.

The Area Commander, Area of the East,

Bluefields, Nicaragua.

Subject: Patrol Report.

1. A patrol consisting of Captain 0.4. Inman, 2nd Lieut. Theodoro M. Stephenson, 2nd Lieut. Jacinto Montenegro, twenty enlisted men and one practicante left Puerto Cabezas the night of July 13th, 1931 to reconnoiter the Wanks river and investigate rumors that bandits were concentrating at Waspook for a drive on Puerto Cabezas. The equipment other than service rifles were two Thompson sub-madhine guns. The events of each day are set forth below:

July 13

Cleared Puerto Cabezas aboard U.S.S. "Sacramento" at 12:00 mid-night.

July 14

Arrived Cape Gracias 7:30 a.m., and enlisted aid of civilians in repairing and equiping water transportation to proceed up river. The only available motor boat transportation was the tug Baldwin and a four cilinder motor boat which had been out of commission for several months. Due to scarcity of gasoline and oil and the heavy consumption of the Tug it was thought advisable to try and recommission the motor boat which, after twenty four hours constant labor, proved to be impossible with material available.

July 15

Additional gasoline and what was presumed to be sufficient lub. Oil to reach Waspook was finally obtained and the patrol cleared Cape Gracias for the upper river at 2215 taking five additional enlisted men and one BAR, also the Master of the Tug, Hugh Fagot, an engineer and pilot.

July 16

Arrived at Saklin 1730 and and into camp with a detachment of ten men and one officer placed in the town. The Indians at the various villages on the lower river would give no information but appeared very restless. At Saklin the people over did themselves in asuring us that there was no sign of bandits on the river above us which immediately aroused my suspicion.

July 17

Tug engine broke down several times. Cleared Saklin for up river at 0910. Attempted to send flank patrol along river bank but due to heavy rains the river trail was impassible. At 1300 one mile below Kisalaya sighted a boat with several men put into the bank in a suspicious manner. On passing found four pit-pans

drawn up to bank but no sign of the occupants. Proceeded on to Kisalaya but natives disclaimed any knowledge of the boats having passed. This information we knew was false. Took four of the indians and two pit-pans to bring boats out to the Tug for examination. On returning found that baats had gotten under-way and gone down river. About a mile further down stream and about three hundred yards above the village of Wasbam sighted two of the boats pulled under the dense foliage on the bank of the river. The Tug was slowed down and the indians ordered to bring the boats out to the tug for inspection. As the pit-pans left the side of the tug heavy fire was opened on us from both sides of the river. The fire was promptly returned raking the dense foliage thoroughly. No target was visable. The contact was made at 1415 and lasted four minutes. The fire from the bandits was promptly silenced. The tug proceeded down the river and landed a patrol of fifteen men under Lieut. Stephenson with orders to proceed back up stream and attempt to gain contact with bandits while the tug patroled the river. Lieut. Stephenson's patrol returned to the boat at 1810 and reported two contacts with the bandits. The first at Wasbam and the senond about a mile further up the river. The last contact resulted in a complete scattering of bandits throughout the heavy underbrush. The patrol also inspected the scene of the ambush and reported that the bandits is presented. that the bandits had lost three dead and three wounded. The Jefe of the group was seen by the patrol leader and several of the men at a distance of two hundred yards. He is reported to be about five feet ten inches and to weight about two hundred pounds; also that he was apparently wounded in the left upper arm. The guide of the group was one Francisco Ellis, the same negro who guided Blandon into Logtown. 1 1815 the engineer reported that we were running low on gasoline and that there was hardly enough lubricating oil to reach Cape. Lieut. Montenegro who had been wounded in both arms during the first contact was in severe pain and exceedingly weak from loss of blood. At 1830 the tug got underway from Ulwas and proceeded down river.

JULY 18

At 0455 arrived at Cape Gracias. Reported contacts by radic and requested planes to evacuate Lieut. Montenegro and a request to Puerto Cabezas to ship us more gasoline and lubricating cil.

July 19

Airplane reports indicated possible presence of bandits between the Coco river and Puerto Cabezas. Radioed orders to First Lieut. Levonski to report to Cape Gracias on first transportation.

July 20

0900 Lt. Levonski arrived Cape Gracias in plane. 0915 I turned over patrol to Lt. Levonski and returned to Puerto Cabezas via plane making a thorough reconnaissance of Coco river as far as Saklin.

2. It is my belief that the bandit group encountered was the first group of a larger movement directed against Puerto Cabezas. The complete routing of that group and the constant presence of airplanes on the river for overal days, is believed to have at least temprarily halted any intended movement against this port. It is very possible that another group still remains between the Coco river and Puerto Cabezas. Should such a group be located it is the intention of the Department Commander to utilize the patrol

at Cabo Gracias to get behind the group and cut off any possicility of retreat up the Coco river.

- 3. It is my firm belief that Adolpho Cockburn and one State (Comandante at Saklin) are in league with the bandits. According to information from an indian messenger of the bandits who was intercepted, Adolpho Cockburn and State received a message from the bandits delivered by this man the morning of the day our patrol arrived in Saklin and when questioned both claimed there was no sign of bandits on the river.
- 4. I wish to bring to the attention of the area Commander the cool and efficient conduct of every member of the patrol, especially under the trying conditions of an ambush. The prompt and accurate response to all orders resulted in the immediate silencing of the enemy fire and the death or wounding of several of the bandits. I especially desire to commend Second Lieutenant Jacinto Montenegro who was in command of the detail on the after part of the tug. Montenegro was shot through both arms from the Honduranian side of the river in the early stages of the action. He concealed his wounds from his men under a rubber poncho and continued to direct the fire of his men until the action was over. This action especially from a young officer under fire for the first time, is, in my opinion, very commendable.
- It is my opinion that the group encountered was an advance group clearing the way for a larger body to follow. All large pit-pans and boats from Kum to Waspook have been taken up the river to the vicinity of Bocay. Persistent rumors indicate that the bandits are badly in need of supplies especially salt, and it is believed that desperation will cause them to make a raid on Cape Gracias or one of the line commissaries. If their plans were to hit Puerto Cabezas in force I beleive they have been, at least, temporarily checked. It is very possible that some still remain on the lower river between Sawa Boom and Kisalaya. Airplanes are endeavoring to locate them. A new road has been cut from Saklin to Sawa Boom at which point the main trail from Honduras meets the Coco river. Whether they expect to get reinforcements, supplies or both from Honduras is not known. Loo patrol has been temporarily left at Cape Gracias for rapid movement up the river in case the planes locate any groups, also to get behind any groups that might attempt a movement from the river towards Puerto Cabezas.

There is quoted a letter from the Department Commander, Department of Chontales, in connection with the work of a small guardia patrol in command of Corporal Santos Castillo V., No. 1253, during recent bandit activities in that Department:

GUARDIA NACIONAL DE NICARAGUA HEADQUARTERS DEPARTMENT OF CHONTALES Juigalpa, 23 July 1931.

From: Department Commander.
To: The Jefe Director.

Subject: Commendation.

l. I take great pleasure in reporting to you a very gratifying series of incidents affecting the conduct of the Guardia Nacional during the occupation of Santo Domingo and Javali Mines on the 18th and 19th instants. I quote for your information the first detailed report received from Cabo Santos Castillo V., No. 1253, Guardia Nacional:

" Santo Domingo, 10 a.m., 23 July 1931. Department Commander.

The bandits came into this town at 5.30 p.m., on the afternoon of the 18th; came in from the side of El Javali, at a place called "Alegre". Raso Felipe Chavarria was at El Javali and he saw when they were coming in and he imm "lately left for the town of Santo Domingo, where I was, without knowing what was happening. As soon as Raso Felipe Chavarria gave me the report that they were coming in I ordered my companions to go with me to a hill which is located on the east side of the town and about 300 yards from the town. On that hill we had a contact with bandit cavalry. After a quarter of an hour of combat I saw that we were surrounded on that hill and I shouted out loud as if to another patrol: "Attack their rear guard" and then we attacked them with more force with revolvers and they broke ranks and we forced through. Then I went into the mountains trying to locate a clear way to La Libertad. I came to the road in the morning and met First Sergeant Mondragon with a small patrol and gave him the news. (Note: First Sergeant was in command of a section of Lieut. Bell's patrol, having been ordered the night before by me to proceed to Javali in charge as Lieut. Bell reported a sprained ankle). Then we hurried our steps towards Javali because we were told that the banalts were drunk and when we got to the town they had gone already. I got information that in the contact we had with them we killed one aid to Pedron. There were several other wounded. The group was made of 250 bandits and they carry about 15 machine guns, rifles and revolvers. CASTILLO, Cabo, G.N."

- 2. From the statements of witnesses to the bandit occupation of Santo Domingo I learn that the above report of Cabo Castillo is a very modest account of the actions of his patrol of four guardias, and yet is concise and accurate.
- 3. Further information received indicates that the timely arrival of First Sergeant Alejandro Mondragon, No.1544 and Cabo Castillo, with their small patrol at the Javali Mines prevented extreme vandalism at that place as the bandits had received information of arrival of a guardia patrol and were evacuating.
- 4. Further on the afternoon of the 20th a small patrol under Cabo Castillo, in pursuit came upon a small group of bandits killed two, captured two and the following articles: Three large red and black flags, eight hat bands, forty-eight cal. .30 rifle cartridges, forty-four cal. .32 short pistol cartridges, papers which were stolen from the municipal offices and a bandit propaganda book entitled "Los Bamqueros y La Intervencion en Nicaragua", (Note: see my telegram 17520 July) nine pairs pants, shoes, shirts,

and womens dress goods.

- 5. Eyewitnesses report that Castillo's patrol in their first contact killed a Jefe on a large white horse who at first was thought to have been Pedron. Both Pedron and Irias were later seen in Santo Domingo however. Whomever it may have been the bandits immediately dug a grave and burried him.
- 6. I cannot too strongly emphasize to you the unfaltering courage of the two small patrols above mentioned and the military tact displayed by their non-commissioned officer leaders. Castillo conducted an orderly withdrawal from Santo Domingo with four other guardia after having given the extreme possible in resistance. The combined patrols of Mondragon and Castillo (about 25 men) returned to Santo Domingo in face of large odds to meet what they might encounter. I recommend to you that Cabo Castillo be promoted to the grade of Sergeant and that he and First Sergeant Mondragon, together with the members of their patrols be commended for especial bravery in action.
- 7. The original patrol of Cabo Castillo was composed as follows:

The members of First Sergeant Mondragon's patrol are not known at this time, but will be reported to you at a later date.

8. Further details will be reported to you in my official report of operations during the past week.

1. The following daily report of an aerial patrol to the East Coast of Nicaragua from July 16, 1931 to July 27, 1931 is hereby submitted, and is to be attached to the "Air Missions Report" of July 27, 1931:

July 16

- 0835 Took off from Managua for Bluefields, planes carrying the following: OL-8-7833, Lieut. Mecker, Comdr., Hale, Pvt., Rosenberg -- OL-8-7637, St-Sgt. Heritage, Cpl. Simmons, Judge Cajina.
- 1005 Landed at Bluefields.
- 1305 Took off from Bluefields for Puerto Cabezas with Mr. Talbot, American Consul, passenger, Cmdr., Hale and

and Judge Cajina remaining in Bluefields. 1500 - Landed at Bluefields - returned because of bad weather.

July 17

0825 - Took off from Bluefields for Puerto Cabezas with Mr. Talbot and Sgt Taylor, G.N., passengers.

1010 - Landed at Puerto Cabezas. No flying in afternoon due to bad weather.

July 18

0835 - Took off from Puerto Cabezas for Cabo Gracias a Dios with

Lieut. Cipolloni, G.N., for wounded guardia.
0930 - Landed at Cabo Gracias. Received information about bandits

from Captain Inman.

1110 - Took off from Cabo Gracias for Puerto Cabezas with Lieut. Cipolloni, G.N., Lieut. Montenegro, G.N., and Sgt. Guatemala, G.N.

1150 - Landed at Puerto Cabezas.

1400 - Took off from Puerto Cabezas and patrolled Coco River from 10 miles above Kisalaya down to Andres. Vicinity of Saklin looked suspicious - many boats on the shore and town unusually inactive. Patrol greatly interferred with by bad weather.

1800 - Landed at Puerto Cabezas.

July 19

1025 - Took off from Puerto Cabezas and patrolled Goco and Waspook Rivers. Conditions on Coco about same as on 18th. Commissary at Yapuwa on upper Waspook had been burned, and town had been deserted. On return trip Sgt. Heritage was forced down by lack of oil at 1400 on a laggon about 30 miles inland and about one mile south of Bambana River.

1445 - Lieut. Becker landed at Puerto Cabezas.

1550 - Lieut. Becker took off with oil for Sgt. Heritage.

1745 - Landed in lagoon-

· 1755 - Both planes took off for Puerto Cabezas.

1840 - Landed at Puerto Cabezas.

July 20

0835 - Took off from Puerto Cabezas for Cabo Gracias with Lieut. Levonski, G.N., and Sgt Guatemala, G.N.

0930 - Landed at Cabo Gracias.

0945 - Took off with Capt. Inman, Lieut. Levonski, Sgt. Guatemala, remaining at Cabo Gracias. Searched Coco River to Saklin for bandits.

1130 - Landed at Puerto Cabezas.

1335 - Took off for Bluefields with Mr. Talbot, Capt. Inman, remained in Puerto Cabezas.

1455 - Landed at Bluefields.

July 21

0725 - Took off from Bluefields for Puerto Cabezas - no passen-

gers. 0750 - Lieut. Becker forced down at Laguna de Perlas, broken carburetor.

1000 - Took off for Puerto Cabezas after motor had been repaired. 1.15 - Landed at Puerto Cabezas. Checked motors in the afternoon.

- 0815 Took off for Coco River area with Lieut. Peterson, G.M., as additional observer in Lieut. Becker's plane.
- O915 Fired upon by bandits at Saklin and at Cockburn farm (East of Saklin). Dropped 18 bombs and fired 400 rounds of .45 Cal. ammunition from Sub-Thompsons. Bombed Cockburn Farm and house on river at northeast corner of Saklin. Large group of horses on Cockburn Farm and boats on river. Two men believed killed; approximately six horses killed or badly wounded; several boats destroyed. Sgt. Heritage later reported at least 16 bullet holes in his plane. Two bullet holes in Lieut. Becker's plane. Contact continued for about 25 minutes.
- O945 Sgt. Heritage forced down south of Coco and about 1000 yards south of Ulan River. Forced landing occured about three minutes after contact and undoubtedly caused by a bullet striking part of his motor. It was impossible to remove plane from this area so Lieut. Becker made drop to him to burn plane and return to Puerto Cabezas on foot. Neither Sgt. Heritage nor Cpl. Simmons were injured in the landing.
- 1035 Lieut. Becker landed at Puerto Cabezas.
- 1205 Lieut. Henderson and Lieut. Bailey with Sgt. Dimond and Gy-Sgt. Royalty as mechanics arrived from Managua in 020-1's 8751 and 8752 respectively. Impossible to fly in afternoon due to bad weather. Lieut. Peterson departed with a 12 man patrol from Dantoni to meet Sgt. Heritage and Cpl. Simmons.

July 23

- 0830 Lieut. Becker and Lieut. Henderson with Gy-Sgt. Royalty and Sgt. Dimond as observers took off in two 020-s to search for Heritage and Simmons, also to make contact with patrol. Failed to locate either.
- 0930 0935 Dropped six bombs on large group of boats on shore at Saklin. Several boats destroyed.
- 1030 Landed at Puerto Cabezas. Weather bad.
- 1415 Lieut. Becker and Lieut. Dailey with Sgt. Dimond and Gy-Sgt. Royalty took off in two O2C's to search for Heritage and Simmons, also for patrol. Failed to locate either.
- 1730 Landed at Puerto Cabezas.

July 24

- 0730 Lieut. Becker and Lieut. Dailey with Sgt. Dimond and Pvt. Rosenberg as observers took off in 020's to look for Heritage. Simmons and patrol.
- age, Simmons and patrol.

 O907 Located Lieut. Peterson's patrol about one mile north of Lecus, on Lecus-Saklin trail. Patrol had not located either Sgt. Heritage or Cpl. Simmons. Patrol was headed toward Saklin.
- 1010 Landed at Puerto Cabezas
- 1030 Lieut. Becker and Pvt. Posenberg took off in 0L-8-7833 for Cabo Gracias.
- 1120 Landed at Cabo Gracias.
- 1230 Took off for Puerto Cabezas.
- 1315 Landed at Puerto Cabezas.
- 1345 Lieut. Becker and Lieut. Henderson with Gy-Sgt. Royalty and Sgt. Dimond took off in O2C's to observe patrol and look for Sgt. Heritage and Cpl. Simmons.

1430 - Located Lieut. Peterson's patrol about 8 miles beyond morning position still heading for Saklin.

1515 - Made pick-up from patrol. Patrol had not been able to obtain any information relative to Heritage or Simmons. Patrol intended to head into Saklin and return on Saklin-Auyapini trail. Patrol was without food. Dropped message to patrol advising them to wait until approximately 10:00 A.M., 25 July, before entering Saklin when planes would observe.

1615 - Dropped message at Cabo Gracias requesting information if any of Sgt. Heritage and Cpl. Simmons. Received None. Lieut. Levonski was reported as being out on patrol at Coco River. Everything in Cabo Gracias apparently OK.

1705 - Landed at Puerto Cabezas. 1700 - St-Sgt. Heritage and Cpl. Simmons reported in at Commandancia, Puerto Cabezas, having returned via Sandy Bay and by boat from there to Puerto Cabezas. Both reported having lost their pistols and sub-Thompson machine gun while crossing rivers and swamps.

July 25

0730 - Lieut. Becker and Lieut. Henderson with Gy-Sgt. Royalty and Lieut. Dailey as observers in 020's took off with food for Peterson's patrol and orders for them to return.

0820 - Made drops to patrol about 12 miles south of Saklin. 0910 - Returned to Puerto Cabezas. Weather on Coco River very bad. Checked motors in afternoon.

July 26

0920 - Lieut, Henderson and Lieut. Dailey with Sgt. Dimond and Gy-Sgt. Royalty took off in 020's to patrol Coco River and to pick up Lieut. Levonski's patrol. Reported as follows upon return.

0955 - Arrived at Coom, and t an patrol eastward along Coco

River. 1015 - Picked up Lieut. Levonski's patrol headed upstream in a

tug and one motor boat. No panels displayed. 1020 - Patrolled river back up to Saklin. All towns flooded by

high water.

1045 - Arrived Saklin. Fifty or sixty boats tied up along river bank, and group of about fifteen horses found near farm of A. Cockburn, one mile east of Saklin. Following explosion of one bomb dropped near horses, three khaki clad men darted from a small outhouse to cover under porch of main house, from which point apparent firing began. Dropped 9 more bombs in area until very low ceiling prevented further bombing. About 400 rounds .30 Cal. fixed gun and 200 rounds free gun were then fired until heavy rains with poor visibility forced stoppage of operations at 1125. About 10 or 12 boats were destroyed. No other effects of fire could be observed.

1200 - Arrived at Puerto Cabezas. One bullet hole was discovered in lower left wing of 0-20-1 #8752.

1520 - Lieut. Becker and Lieut. Henderson with Capt. Inman and Sgt. Dimond as observers took off in O2C's to pick up

Lieut. Levenski's patrol. 1630 - Picked Levenski's patrol on river two miles east of Saklin.

Made two drops to them. Continued to fly over Saklin until

Levenski's patrol landed. Dropped 6 bombs and fired 400 rounds fixed gun and 400 rounds free gun to discourage any

attack on patrol while landing. Landing completed without opposition. 1815 - Landed at Puerto Cabezas. July 27 0935 - Lieut. Henderson and Lieut. Dailey with Sgt. Dimond and Gy-Sgt. Royalty took off in 020's to pick up Lieut. Levonski's patrol and to patrol Coco River. 1010 - Arrived Saklin. Town appeared deserted. Five bombs dropped on group of boat. Itill remaining in river. 1025 - Patrolled eastward along Coco River. Picked up Lieut. Levonski's patrol at 1035 headed toward Cabo Gracias. No panels displayed. 1100 - Arrived at Cabo Gracias. Nothing unusual observed. 1140 - Arrived at Puerto Cabezas. 1300 - Lieut. Becker and Pvt. Rosenberg in the amphibian and Lieut. Henderson, Lieut. Dailey, Gy-Sgt. Royalty, and Sgt. Dimond in O2C's took off Puerto Cabezas for Managua. 1545 - Landed at airdrome Managua. Total number of bombs expended: 40 Total number of rounds .45 Cal. expended: Total number of rounds .30 Cal. fixed gun expended: 900 Total number of rounds .30 Cal. free gun expended: 800. STATEMENT OF STAFF SERGEANT GORDON V. HERITAGE On the morning of 22 July, 1931, Lieut. Becker, flying airplane OL-8 #7833, with Pvt. Rosenberg, observer, and myself flying airplane OL-8 #7837 with Cpl. Simmons, observer, took off from Puerto Cabezas for a patrol. We headed toward Saklin which is about one hour flight up the Coco River from Cabo Gracias. While flying low over Saklin about thirty minutes. I dropped nine bombs, eight of which ex-

both planes were fired upon, starting an engagement which lasted ploded upon impact. After a signal from Lieut. Becker, we headed back toward Puerto Cabezas. Jess than five minutes after we left Saklin, my engine slowed down to the extent that it was just turning over, and I was forced to land in the swamp which was just across the Mogo River and east of Saklin. This was at tenfifteen A.M. Neither one of us were injured in the landing although the left lower wing and tail section were damaged. Even if it had been possible to make repairs, it would have been impossible to remove the airplane from that place as the mud was waist deep. After receiving orders from Lieut. Becker, we burned the plane and headed for Puerto Cabezas with as much speed as the condition of the swamp and our load permitted. The pack which we salvaged from the plane consisted of a Sub-Thompson, compass, maps, first aid kit, Very pistol, two .45 Cal. pistols, a machete, and emergency rations.

We travelled all that day and some of the night, swimming five rivers and chopping our way through jungles. Themfifth river we crossed, it was a matter of losing the sub-Thompson or sinking with it, so, it was abandoned. We stayed for a few hours under a lithle thatch roof that we found late on the night of the twenty-second. The following morning, we started out once more, and about six o'clock, struck a heavy swamp wading from our waists to our necks. We continued on until about three in the afternoon at which time we were picked up by two friendly Indians from Sandy Bay. We had lost our pistols during the

morning, and all that we had left now was a machete and a first aid kit. We arrived in Sandy Bay about four in the afternoon.

During our journey, every patch of wild sugar cane we came to we cut up into short sticks and chewed on the way. River water was the only thing available for drinking purposes.

We stayed in Sandy Bay the night of the twenty-third, and left at six the next morning. The remainder of the journey to Puerto Cabezas was made in a small twenty-five boat by way of the sea. We arrived at Puerto Cabezas about five o'clock in the evening on the twenty-fourth after traveling the last lap in a steady rain. It rained at frequent intervals throughout the entire trip.

After the forced landing, and before the plane was set on fire, we counted isxteen bullet holes in the wings and fuse-lage. Judging by the action of the engine, it is my opinion that some part of the fuel system had been penetrated by bullets. We were very close to Saklin, and because it is estimated that there are more than one hundred bandits operating in this area, we did not remain long enough to give the airplane a thorough inspection to determine exact cause of engine failure.

NOTE: In the above contacts 20 bandits were killed and 6 were wounded, the Guardia had two (2) killed and 6 wounded. In addition to the above known number killed and wounded bandits, two (2) more were killed by aircraft machine gun fire in the Chontales area on 16 July 1931. On 4 July 1931, Lieut. Stewart's patrol fired on and killed three bandits who tried to escape from house on approach of the patrol. Following articles captured by patrol of Cabo Castillo of Javali Mines station: 3 Red and black flags, 8 hat bands, 48 cartridges, rifle cal. 30, 44 cartridges, pistol cal. 32; 50 cartridges rifle cal. 22, 9 pairs of trousers, 4 pairs shoes, 4 shirts, 200 yards womens dress goods, 10 yards shirting material, 1 propaganda book and papers stolen from Hunicipal Office. In addition to all of the aforementioned captures, the Guardia captured various miscellanes a articles of plunder.

Captain R. Arnett, G.N., Commanding the Department of Esteli, reports the following for the month of July, 1931:

The harvesting of the new corn crop has started and there is now plenty of corn for the people. The bean crop will not be so plentiful due to the heavy rain which is ruining the crop before it can be harvested. Food prices continue to be high. Sugar sells for \$10.00 per hundred pounds, rice \$10.00 per hundred pounds, lard \$9.00 per can of forty-five pounds and eggs thirty cents a dozen.

Friendly relations exist between the guardia and civilians.

The Political situation is without interest.

Roads are very muddy and travelling is difficult.

The rain fall has been very heavy for the month. Limay reports that they have had a continual rain fall of eighty hours at one stretch during the month. All rivers are very high.

On the morning of July fourth, the Department Commander with the assistance of the other officers, rationed out five hundred "Nacatamales and Coffee" to the poor people in front of the Cuartel. Money was also given in order that the poor might be able to buy a little for their needs. Games were held and prizes given. In the evening a dance was given by the officers and was well attended by all citizens. The home of a prominent Nicaraguan citizen was donated for the purpose and was decorated with red, white and blue streamers with the merican and Nicaraguan flags suspended from the ceiling. Each table contained a vase of flowers. Dancing commended at 9:00 p.m.

Sunday, July fifth, the Guardia Officers paid for a two hour band concert in the park which was well attended and appreciated by all inhabitants. In the afternoon the cuty orchestra gave a special concert to the officers of Esteli. This was also well attended by the people of the city.

The following are extracts from the "MONTHLY RECORD OF EVENTS" of the Department of Chinandega, commanded by Captain E. A. Craig, G.N., for the month of July, 1931:

POLICE OPERATIONS: Very good. The past two months have shown a decrease in crime and an increase in the number of individuals apprehended for old crimes for which they are wanted by the civil courts. Due to the large number of Municipal Guardias on duty on all important towns, the regular guardias are left free to operate in the country districts and as a consequence the people in these districts are enjoying a sense of security that they have not had for some years, also the small groups of ladrones who formerly operated in these isolated sections have practically disappeared.

INTELLIGENCE: State of , territory occupied quiet. The people of this department are becoming very villing to voluntarily come to the Guardia and give information, and during the past month the information so obtained has indicated that the department is in a very quiet condition. The greatest source of danger in this department is the Estero Real where gasoline launches and canoes can easily enter from the Golfo de Fonseca coming from Honduras and Salvador or Mexico and bringing contraband of all kinds; the country along the Estero Real is so swampy as to preclude effective patrolling and there are hundreds of inlets which, on account of the swamps, are sometimes separated by a days march one from the other, and on this account it is easy for the launches to enter and get their cargo ashore. The only effective way to stop this contraband running is to have a Government launch in the Estero Real under command of a Guardia Officer, which could stop and search all boats entering from the Golfo de Fonseca. It is believed that such a Government launch would be well worth the money, not only because it would increase the revenues of the country on imports but because it would stop effectively the introduction of arms and ammunition which at the present time can be introduced into the country and used against the Government via this route.

MILITARY SITUATION: No armed group of any size is believed to be in this department at the present time. On July 31, a small finca near Posoltega was assaulted by a group of about nine men some of whom were armed; these men stole some clothing and small articles. Fatrols operating from Chinandega and Chichigalpa apprehended four of this group the next day, recovering the stolen clothing and capturing two shotguns. This is the only report of ladrones received during the month.

ECONOMIC CONDITIONS: Prices of foodstuffs have risen during the past month. Prices of principal articles are as follows: Eggs, forty cents per dozen; Lard, \$\psi^14.00\$ per five gallon can; Rice, \$\psi^6.00\$ per hundred pounds; Cheese, \$\psi^3.00\$ per twenty-five pounds; Coffee, \$\psi^8.00\$ per hundred pounds and Beans \$\psi^20.00\$ a fanega.

RELATIONS BETWEEN GUARDIA AND CIVIL POPULATION. There has been no friction between the Guardia and the civil populations. The standing of the Guardia among the civilians is high and they are gaining their respect more each day. Cordial relations are maintained between the Guardia officers and the civilian Officials of all the towns with the result that their hearty cooperation can always be obtained in any matters effecting the Guardia.

POLITICAL SITUA-TION: Normal. Campaingns for the elections of new Alcaldes are being carried out with large paredes, sometimes consisting of five hundred mounted men carrying placards with propaganda through the streets. Guardia mounted patrols and through the maintain order at these demonstrations and to date no trouble of any kind has occurred.

WEATHER: Warm and sultry. Heavy rains each day.

ROADS AND TRAILS: In bad condition. Heavy rains make some of the fords very dangerous to cross. Automobiles can only use the road between El Viejo and Chinandega at the present time.

Captain H. M. H. Fleming, Chief of Police of Managua, reports the following for the month of July, 1931:

"Police operations have continued to grow day by day as shown by the increase report of arrests. Petty larceny and drunkenness constitute the bulk of the offenses as usual, but the situation is one to create a slight feeling of alarm. There is no doubt that as far as thefts are concerned, conditions are the worst now that they have been in almost two years. The police are practically helpless in combating this type of crime due to the ease with which houses can be entered now. To make conditions worse, the August fiestas begin at the end of this month, and theft and drunkenness will increase. An effort will be made this year, as last, to confine arrests to the cases that merit it particularly.

The installation of 1st Avenue, West, as a one way street south, and the opening of Calle Central as the west bound one way street has done much to eliminate automobile accidents, and to make those that to take place minor ones.

The detachment of 19 men and one officer to Chontales for temporary duty has made the police work of the city very hard, as it has caused posts to be doubled and created a lack of reserves.

Economic conditions are becoming better in many ways. Friction between the people and the Guardia has decreased. They has been very little political activity. Rain fall has been great. Roads and trails leading out of Managua are good.

The increase in the Policia Urbana from ten to fourteen men has been a marked help to the force, as these additional four men were recruited from those we had had before. I have been trying to get the Distrito Nacional to allow a further increase trying to get the Distrito Nacional to allow a further increase of this force, but to date this has been without success.
