Captain R. E. Forsyth, G.N., Commanding the Department of Rivas reports the following for the month of July, 1931:

"" Small cases of petty larceny continue, but conditions greatly improved. Due to scarcity of food in some parts these small cases of stealing continue. No major crimes committed during month, and the department quiet.

Economic conditions poor, but improving. No friction between the Guardia and civil population.

Coming elections for Alcalde causing some political movement, but no disturbances noted. No propaganda issued. It has been reported from reliable sources that 400 litres of aguardiente have been set aside by the liberal party for use in spreading propaganda for the Municipal elections. During early part of month it looked as there was to be a split between the upper and working classes of the liberal party due to the decision of the candidate for alcalde. No definite decision made as to candidate for either party up to present date. Parties are continually changing due to something being dug up about another's past.

17.06 inches of rain during month. Roads and trails very bad to Cardenas and San Juan del Sur. Good to San Jorge and fair to Buenos Aires and Potosí.

There has been no noted change in the amount of petty robberies committed since last report and there have been no large robberies. Due to shortage of funds caused by the small amount of guaro being sold, the police force of Granada has been reduced by placing eleven men on leave without pay. Continual patrols commanded by officers and non-commissioned officers are being sent out to run down contraband; several stills and a small amount of contraband have been captured. It is not believed that the small amount of guaro sales is caused by large sales of Cususa, but by a general economic depression.

General state of territory occupied, quiet. The sugar harvest has been completed; there is an increase in the unemployed. The political situation is active due to the coming elections for Alcalde. Civilmand press attitude towards the Guardia, friendly.

The following extracts are quoted from a letter received by Colonel L.P.Hunt, G.N., commanding the Northern area, from Lieut. E.L.Livermore, G.N., commanding the District of Totogalpa:

-----------

""Everything is so quiet here that I am looking for plenty of trouble later on; everyone claims that there is not a sign of banditry.

I am more than satisfied with the way they have cleaned up Cuje; several of the Gente from there have invited my guardias and me out there to a corn roast this week, so I guess we will have to go and give them a little talk, for these people are 0.K. now."

The following letter and sketch was submitted to the area Commander, Morthern area, by Captain J. O. Brauer, G.H., of Palacaguina. This matter has been taken up with the Department of Public Works:

HELDQUIRTERS, DISTRIC OF PALACAGUIHA, NICARAGUA, GUARDIA HACIONAL, 14 august 1931.

Dear Colonel Hunt.

In behalf of the people of this district and some of the prominent citizens of Telpaneca, I am writing you regarding the completion of the "Carreta" road between here and Telpaneca. The matter has been near to my mind ever since taking over this district, but I have succeeded only in the last month to assemble sufficient facts to constitute a somewhat intelligent report. During the past several months I have had occasion to inspect this road and have paid particular attention to the important details when passing thereon in order that my knowledge would be first hand. In addition to this, the opinions of several persons who use the road regularly have been obtained.

To begin with, that part of the road which has already been completed remains in not excellent but good conditions, and very little work will be required thereon. The entire length of the road is approximately six leagues, three and a half of which is completed, therefor leaving only two and a half leagues to be finished which is indeed less than half. The most difficult construction has already been completed, that is the heavy grades leading out of Telpaneca and Concepcion, to the uncompleted portion which follows the LIMON Hountain Range.

The soil along the entire length of this read is a sandy loam and appears to resist the heavy rains very well. This is evidenced by the fact that part of the read was completed over two and a half years ago and still randing in good condition. The upkeep of this read when completed will be below the nominal upkeep of other reads in Segovia due to the soil and ground conformation.

Along the portion which remains to be completed there are several stretches which will require no work and several others which will require only a small amount of grading. This cuts the cost of this piece of construction considerably.

After obtaining estimates on the cost of completion of this road from several persons here and of the district of Telpaneca and with my own, the conclusion was reached that the cost thereof would approximate \$1,500.00. These estimates varied from \$1,200.00, my own of course, to \$1,800.00. It was practically agreed that the work would employ thirty men with three overseers for a full sixty days. This is for only the uncompleted portion of the road and the repair of the uncompleted part will require the same number of men for a period of fifteen days. My idea is that the people of the two districts could take care of this latter during the three days of road work which is required of them each year by the Government, and thus eliminate this cost. This estimation of the time required and the number of men necessary is made with the idea in mind that the work be completed during the rainy season when the ground is soft. If it is undertaken thereafter a greater expenditure will be required.

The following is believed to be the most conservative estimate and still guarantee the completion of the road:

In addition to the reduced cost obtained by eliminating the repair of the old road I think the cost could be further reduced by the use of the  $_{\rm P}400.00$  surplus in the road fund of Telpaneca.

Regarding the importance of this road to the people of this district and more particularly so to the people of Telpaneca there is much to be said. Also the districts South of here will agree as to the importance of it since they will also benefit by its completion. First of all it is the only commercial route to the South for Telpaneca for the others are entirely too mountainous and circuitous. Secondly the people of the district of Telpaneca have suffered for want of some means of getting their coffee and other produce out of the district. That district produces a large surplus of coffee particularly and also corn and beans. In ordinary times the amount of coffee which leaves that district exceeds 10,000 sacks or quintals. This must all be taken on mule-back to the nearest "carreta" road for further trans-portation South. During the last two years only about a fifth of this amount was gotten out. This was due of course in part to the difficulty encountered in harvesting it but there was also another cause. The people were afraid of losing not only their cargo but their animals to the marauding bandit groups. At present to carry coffee out of the district ten mules are required to transport the load of a carreta drawn by four bulls. (The bandits's interest in these latter animals is nul for they are too tough to eat and travel too slowly to drive them to Honduras). When the surplus is small it is evident that there is then greater necessity of

Jo glen Brauer Capt. J. n. marketing what is on hand. The completion of this road would them permit the people to send their produce out regardless of the bandit conditions in the country. Thirdly the people in the districts lying to the south of here will benefit by the reduced cost of transportation.

The construction of this road is a matter of importance to the people of these two districts in another way. At the present time, and such will continue for several months, there is no means within the districts whereby the people can earn money to buy much needed clothing. They will now work for less than they will later, for the necessity for ready cash is now much greater than it will be after they can sell their corn and other produce. The people are very anxious to see construction began here because of this necessity and should the matter be arranged it will be of more than a double service. The receipt of this tangible and immediate benefit will do more than any other one thing to rally the people to the support of the Government and the Guardia.

In discussing the matter with the people here and of Telpaneca I have received many requests that I take the matter up with their deputies in Managua, Camilo Lopez Irias and Juan Simon Padilla, but since that is beyond my prerrogative they were informed that the matter would be taken up by you from Ocotal and after assembling the most pertinent facts I am submitting them to you in hopes that you will be able to render them the service desired.
