GUARDIA NACIONAL DE NICARAGUA, Macuelizo, N.S., Nicaragua, 21 August 1931.

From: Sub-Tnte. Joseph M. Broderick, G.N. To . Area Commander, Northern Area.

Subject: Patrol, report of.

1. In accordance with your verbal instructions I cleared Macuelizo with ten enlisted for the purpose of apprehending Honduran revolucionarios reported to be near Oyote (134-263).

## 18 August 1931

0700 Cleared Macuelizo.

0750 Passed Amatillo (163-374).

0830 Crossed Cerro Marimacho (160-375).

0920 Passed La Palma (156-373).

1130 Passed Icalupe (143-370).

1200 Passed Los Lumbreros (139-371).

1250 Arrived Yaraje (137-372) and camped. Nothing to report. Trails dry and in fair condition.

## 19 August 1931

0630 Cleared Yaraje (137-372).

Arrived Santa Emelia (129-374). Don Ramon Moncada gave me the following information: "Carlos Salgado is reported to have died of fever about nine days ago in the Department of Chinandega. A woman passed here about eight days ago and said she saw Juan Pablo Umanzor in a house near Las Manos, Honduras (190-409) and that he appeared to be dying of small-pox. I know nothing of armed Hondurans who are supposed to be hidding out near the border. All the border is talking of a rumor that says that the thief Ventura Rodriguez was shot "por ellos mismos".

1000 Cleared Santa Emelia (129-374).

1208 Passed Las Manos de Leon (130-370).

1310 Passed Yare, Honduras (129-371).

Arrived at Hacienda Oyoto (134-363) and camped. Nothing unusual noted. The hacienda Oyoto and the house of the Yakis family are the only two houses in Oyoto that are on the Nicaraguan side of the Border. Questioned all people who arrived on the Nicaraguan side of the Border but all appeared to be ignorant of the presence of Honduran rebels hiding in or near Oyoto. I do not think it likely that Honduran rebels would attempt to hide in or near Oyoto due to the fact that General Plata's Headquarters are in San Marcos, Honduras, about an hour and a half from Oyoto.

" M " COMPANY, GUARDIA MACIONAL, JINOTEGA, NICARAGUA. 24 August 1931.

From: The Commanding Officer.
To: The Area Commander.

Subject: Patrol report, 21 August 1931 - 23 August 1931

Reference Verbal orders of Area Commander, 21 August 1951.

- l. The patrol consisted of Captain R. L. Griffin, Jr., Lieut. Wm. A. Lee, and twenty-one enlisted. The patrol was armed with two (2) BAR's, four (4) Sub-Thompsons, six (6) Rifle Grenade Discharrgers, nine (9) Krag Rifles and two (2) pistols, Colt .45 automatic.
- 2. The mission of the patrol was to investigate reports of a large group of bandits in the vicinity of La Concordia and to cooperate with patrols from Esteli and Yali.
- 3. Friday, Aug. 21, 1931 Patrol cleared Jinotega at 0710 with objective the Colon Valley to South west of La Concordia. One Guardia was taken sick just out of Jinotega and returned to Jinotega leaving patrol with twenty (20) enlisted. Patrol proceeded via Ocotalia, Hesita, Santa Barbara, Loma Lanza, Espinales, Sacascli, Lomita and Nomanji into the Colon Valley. Made a circuit of the Colon Valley and met Esteli patrol at Ubeda's sugar mill in Colon Valley at 1530. Esteli patrol reported to us that they had information of bandits in Carbonales the morning of the twenty-first. All inhabitants enroute were questioned and side trails in valley examined but we were unable to get any reports of or see any signs of bandits. My patrol at about 1400 was within one-half league of Carbonales and found no reports or signs of bandit activities. At decided to rest for the night at Ubeda's sugar mill and to proceed to La Concordia Saturday morning for information. Directed Esteli patrol to sleep at other sugar mill about one thousand yards up trail and to be ready to proceed to La Concordia at 0630 Saturday morning.

Saturday, Aug. 22, 1931 - Cleared Sugar mill at 0620, picked up Esteli patrol which was mounted and sent them ahead as

point. Arrived La Concordia at 0820. No reports or signs of bandits enroute. Captain Small (and patrol from Yali) was in La Concordia.

Upon our arrival, Captain Small had received no bandit information since clearing Yali on Friday. Captain Small telegraphed situation to San Rafael and requested information. Answer from San Rafael at 1100. No information except Area Commander ordered all patrols into their respective stations. Reported to the Area Commander by telegraph at 1100 and acknowledged orders. Cheared La Concordia at 1310 for San Rafael and reported departure to San Rafael and Jinotega. Arrived San Rafael at 1440. Reported to Area Commander and spent night at San Rafael.

Sunday, August 23, 1931 - Cleared San Rafael at 0840 for Jinotega and reported departure to Jinotega. Arrived Jinotega 1220.

4. The patrol was unable to find any indication of bandit activity. Information received was that there has been no bandits in the territory covered within the last fifteen days. It is the opinion of the patrol commander that the original report of a large bandit group near La Concordia was based on misinformation.

The following letter describing some of the conditions in Totogalpa, is quoted:

GUARDIA NACIONAL DE NICARAGUA DISTRITO DE TOTOGALPA. 21 DE AGOSTO, 1931.

From: District Commander.

To: Area Commander, Northern Area, Ocotal, Nic.

Subject: System used for issuing Boletas de Ocupacion at this station.

- 1. The following is a report of the system used for issuing Boletas de Ocupacion in this District.
- 2. Took command of this Station 16 May, 1931. At that time there were 250 men with Boletas de Ocupacion.
- 3. Instructed Alcalde to order all Jueces de Mesta and Jefes de Canton to report in here for instructions. Upon their reporting, they were given instructions in their duties, Laws of the Republic, cleaning their districts of thieves, and part time bandits.

Instructed them and told them that they had authority to arrest thieves, and bring them to this Headquarters for punishment; also informed them that all honest citizens would have to present themselves here, and that they would be issued Boletas de Ocupacion. Sunday was the day chosen, for on that day it would not interfere with their work. On the second Sunday, 450 presented themselves, an increase of 200 over previous week.

Jueces de Hesta and Jefes de Canton began to arrest thieves, bringing them with the cattle they had killed as evid-

ence. The Jueces de Mesta and Jefes de Canton have arrested a total of 18 cow and corn thieves; after this more people began to present themselves. They would send in word by their friends, asking if they could come in or not. The reply was that if they were willing to give the District a days work, such as cleaning trails, they could come in. The total up to this date that have presented themselves here has reached the 600 mark, there are more yet.

Out of the 600, thirty six were either bandits or part time bandits. One Blas Gonzalez, named Captain by Sandino, turned in with a Rifle. Another Abraham Zamora, of Blas Gonzalez group, with a serviceable Con-Con Remington Model Rifle. Pascasio Gonzalez of the same group turned in with a cutacha, and several others with cutachas and others with

- information.
  4. The gente from all six Valles of this District have cleaned all main trails, and a greater part of the small cross trails. A close check is kept on those that have worked and they are given credit for their work.
- 5. On each Sunday at 1:00 p.m., they fall in at these Headquarters and are given talks on their Government, supporting their Government, instructed to plant and harvest more crops, the value of peace, and a clean life; that the Guardia Nacional are intirtheir enemies, but their friends; after all of this they "vivan" the Republic and the President of the Republic.

They were told that if they did not participate in the Parades they would be punished by giving them a days work on the trails, that snapped them out of it.

- 6. On 5 July three head of cattle were killed and stews and soups were made and given to the gente. At the same time they were vacinated by the Area Surgeon, Dr. Bach. From then on it has been easy here, for a bandit group can not move in any Valle without either the Gente or Jueces de Mesta notifying me.
- 7. A list of all the Valles are kept separate at these Headquarters. Boletas are numbered from one up for each Valle. There are six Valles, seven with the Pueblo:

- 8. The Jueces have been authorized to carry cutachas and are giving the best of services.
- 9. It is believed that if the Parades were organized in all Districts much better results would be gained.
- 10. One of the ex-bandits, Pascasio Gonzalez of Cuje, invited the guardias of this Station to his house for a Corn Roasting party on 19 August; cleared with a patrol of twelve enlisted, and several civilians, arriving at his house about 10:00 A.M.

He had trails all decorated with flowers, foliage, etc., all Jueces were present, and a total of about twenty-five civilians. They gave the guardias, Roasting Ears, can-

dies made from new corn and dulce, hot coffee and queso. The guardias enjoyed it very much, I myself enjoyed it, for it was the most peaceful scene I have seen during 26 months in the Segovias. /s/ La. L. Livermore, Sub-Trte., G. N. Aug. 22 - Captain Forsyth, Department Commander, and guardia patrol cleared Rivas for and arrived San Juan del Sur. Aug. 23 - Rivas guardia patrol cleared Rivas for Tola to maintain order during a local political meeting. Returned to Rivas. Lieut. Schneeman cleared Rivas for El Rosario; returned to Rivas; nothing to report. Aug. 24 - Rivas guardia patrol cleared Rivas for Tola in search of lost animals. Returned to Rivas with the recovered property. Captain Forsyth and guardia patrol returned to Rivas from San Juan del Sur. Lieut. Poore cleared San Juan del Sur by seaplane for Managua. Guardia patrol, and Juez de Mesta cleared San Jorge for La Virgen to capture three thieves. Returned to San Jorge, mission successfully accomplished. Lieut. Bello and Cardenas guardia patrol cleared Cardenas on reccoinnance patrol. Patrolled Punta de Las Piedras, Buena Vista, Guanijiquil, Peña Blanca and Sapoa and returned to Cardenas; area reported as quiet. Aug. 25 - Captain Forsyth and Lieut. Schneeman cleared Rivas for San Jorge to inspect. Returned to Rivas. Aug. 26 - Rivas guardia patrol cleared Rivas for Tola. Patrol returned to Rivas with one civil prisoner. NOTES FROM THE POLICE COMPANY OF MANAGUA Now that the conditions in Chontales have quieted we are awaiting the return of our men so that we can increase the patrolmenon the streets of the city. ...lso the return of the Lieut. Bell will release Lieut. Martin from desk work, and he can resume his functions in charge of traffic and finger prints. The Distrito Nacional has authorized the enlistment of ten more Policias Urbanos, which will bring our total up to twenty-four. The greater part of these men will be those who were with us in the same capacity before the earthquake. Weedless to say the enlistment of these men will be of great assitance as soon as we can get uniforms for them. -13Traffic accidents have been on the increase for the past month, and as soon as Lieut. Martin is free, a strong campaign will be started against speeders.

Robberies in the city continue but they are all of a petty nature, and have decreased during the course of this month.
