

Following gives a brief summary of the situation re-operations under command of Col Watson in Depts of Chinandega and Leon, Nicaragua up to 9.00 A.M. 14 February, 1932 .-:

Leon, Nicaragua. - - - - February 13, 1932.

The situation up to 9;00 AL.

At 11;00 A.L. 12 February a message was received from Captain Trumble stating that the bandits had been in a place called El Salto near the Hacienda "El Queso" on the 11th and that he and Captain Brauer were expecting a contact before noon.

Captain Brauer with a patrol of Cadets arrived in San Juan at 7;00 PM. having covered the area along the Estero Real Ric from Valle de las Zapatas. He was ordered by telegraph to proceed to Chinandega but an acknowledgement of this message has not been received.

Lieutenant & cDonald covered the area north of Chichigalpa and this morning reported from Telica that he had had no information. He was ordered to return to Leon.

Lieutenant Clark is moving north with his ultimate destination El Sauce.

Lieutenant Spart has been ordered to cover the area south of San Pablo to the Rio Tecomapa and S. Nicolas then north. He will be ordered to Villanueva.

Lieut Darrah is moving north with his destination El Sauce.

Lieut Griffiths has been ordered to proceed to Achuapa via Jocote and await orders.

Captain Trumble is north of the Rio Estero heal and if he can be located will be ordered to El Sauce or Valle de las Zapatas.

Lieut Centeno is at Valle de las Zapatas.

Fifteen men from the northern area who were at El Sauce are enroute to Limay where they revert to control of Northern Area.

Patrol at Condega has reverted to control Area Commander.

The owner of the fines La Pelona with the information that bandits on Tuesday called on his mandador for \$400.00. This place is in vicinity of Olomega. Capt Elmore being ordered to operate in that vicinity for purpose of endeavoring to locate this group. It may well be that they have some north again.

THE SITUATION UP TO 9;00 AM -- 14 Pebruary, 1932.

Captain Brauer with his patrol was ordered to Chinandega from vicinity of Puente Real. While passing through Abreje he reported that he heard a shot fired but an investigation revealed nothing. After his arrival in Chinandega information was brought in that the bandits under Salgado were between Puente Real and Tempisque. Captain Brauer with two officers and 25 men were ordered to Abreje and he arrived there at about 2;35 AM. He forwarded a message saying that the bandits, 300 in number had left there three hours before going in the direction of El Chonco mountain and that he had a guide who said he would take the patrol to the camp. Captain Brauer asked for reinforcements which were sent vis truck. He also stated that he expected Captain Trumble to be in Puente Real and would communicate with him by runner.

Captain Brauer with about 50 men will be enroute to the El Chonco by noon. Captain Elmore with Lieut Centeno and 28 enlisted will be moving west from the vicinity of Olomega by this afternoon. Lieut Gomez with 25 will be

proceeding north from Chinendese. Lieut Spart will be moving south from San Pablo and Captain Trumble should be along the Richard Lieut Griffiths is investigating the report of Colindres moving south through Valle Ocotal and Lieut Darrah's whereabouts are not exactly known at this time althouth he should be between Valle de las Zapatas and Portillo (south of Pilon).

The 25 Auxiliares enlisted at Leon are with patrols, 15 Auxiliaries of this number and 10 Cadets and men from Darrahs patrol now at Leon leave for Chinandeja by train this moon and this force will constitute the patrol Lieut Gomez takes.

- l. In compliance with the above reference, a patrol consisting of fifteen guardias under my command, cleared Puerto Cabezas at 0400, 17 January, 1932, via motor cars for Sula Farm (157-324) on the Standard Fruit Railroad Line.
- 2. The mission of the patrol was to proceed to Sula Farm and pick up the trail of bandits reported to be in that vicinity.
- The patrol was armed with the following weapons: one B.A.R., one S.T.M.G. and fifteen rifles.
- 4. The contact took place at Browns Camp (158-320) on the Standard Fruit hailroad Line at 1815 January 18, 1932 and lasted about fifteen minutes.
- 5. The following arms and articles were captured from the bandits: one rifle hemington, repeating; three cutachas, one canteen US, two red and black hat insigniss.
- 6. Bandit casualties were: one known dead, wounded unknown. There were no Guardia casualties.
- Patrol arrived at Sula Farm at 0630 and found the place deserted. The mandadors house and six labores houses had been burned, the almost decapiteted body of the mandador was found nearby. A thorough search was made for several hundred yards around the farm for possible traces of bandit trail leading out, but due to the fact that it had rained heavily during the night obliterating. all traces, we failed to pick up their trail. Patrol then proceeded toward Tungla and Moss Farm. Questioning of natives along the line failed to disclose the possible location of the bandits or the whereabouts of the Sula laborers. Arrived at Moss Farm at 1100, where I received a telephone message from the District Superintendant at Wakiwas that one of the Sula laborers who was captured by the bandits had escaped and reported at Wakiwas. Patrol cleared Moss Farm and arrived

at Wakiwas at 1200. Upon being questioned this man disclosed the fact that the Bandits were from (150) to (200) strong, well armed, jefes Frias and Gonzalez, and that at the time he made his escape during the night the bandits had moved into the jungle in position west of Brown's Camp, and that their intentions were to raid the commissary at that place. I reported this information to the Department Commander, by telephone, and was ordered to proceed to Brown's Camp at 1600, picked up four more Sula laborers at this place, who had also escaped from the bandits. These people stated that the bandits were about (6) kilometers west of Browns Camp, and had no food other than the two heads of cattle taken from Sula, and had been existing on little more that bananas for several days and were desperate, and would be forced to loot a commissary to procure food. I reported the developments to the department commander and was ordered to remain in Brown's Camp for the night and await further instructions. At 0900, the 18th, the Area Commander and the Department Commander arrived at Frown's Camp with a patrol of ten Guardiss. I was directed by the Area Commander to take a patrol of fifteen men and scout the area in which the bandits

were reported. About (3) kilometers to the west we found where the bandits had camped the night of the 16th. camp consisted of thirty seven leanto huts, some large enough to accommodate eighty men, a cut tuail led from the camp toward the Pis Pis trail, followed trail for about two miles then returned to Brown's Camp and Lacos, a commissary (7) kilometers to the south. My patrol was reenforced by five men and it was decided that I leave a guard of one Seargent and seven men with an automatic weapon at Brown's Camp, and as soon as darkness set in, proceed with the remainder of the patrol to the Vance District, get additional men from the Kipls Farm detachment and lay an ambush at three points where it was thought the bandits would come out. The Area Commander and the Department Commander with five men cleared for the Vance District at 1400. At 1800 I attempted to get in touch by telephone with Lieut Reyes, at Kipla Farm but found that the line was dead, suspecting that the bandits had cut the line between Port and Brown's Camp and were probably looting the Lacos commissary, I got in touch with Lieut Gaitan at Moss Farm and gave him the datails, directing him to proceed immediately with ten men to Brown's Camp and remain at that place, that I was clearing with my patrol toward Lacos Commissary,. At 1815 while preparations were being made to move, bandits opened fire from three sides. Patrol returned their fire taking position along the railroad embankment. After fifteen minutes of firing a bugle was sounded and the bandits ceased firing and retreated in all directions. As it was pitch dark and raining no attempt was made to pursue the bandits. At 1840 Lieut Gaitans patrol arrived, and at 1900 Sgt Saenz with thirteen men arrived from Kipla Farm and reported that the telephone line was cut two kilometers below Brown's Camp. I directed Sgt Saenz to proceed with his patrol to Lacos commissary and remain at that place until further instructions. After dispositions were made for the night I took eight men and proceeded to Sants Cruz junction and from there reported developments to the Department commmander, picked up a line repairman at Siksikwas and returned to Brown's Camp. Communication between Port and Brown's Camp was established at 0500. As soon as sufficient light permitted in the morning, a thorough search was made of scene of contact and vicinity, the remains of one bandits, a rifle and other articles were found. Due to fact that the bandits had scattered in all directions and it having rained heavily all night no definate trail was found. Scouts who were sent out at daybreak returned in the afternoon failing to find any traces of the bandits location.

Summary of situation of patrol operating under Col Watson in Depts of Leon and Chinandegs.

CHINANDEGA, NICARAGUA 8:00 AM 17 February 1932.

The situation up to this time.

After returning from Campuzano the bandits proceeded in an eastern direction having arrived at Candelaria at 2:30 Pm Sunday the 14th. While the bandits were being trailed by Captain Trumble's patrol they seem to have turned the tables and we find them on Sunday following Trumble's patrol through San Juan, Las lercedes and Candelaria. After taking everything in the later place the bandits disappeared again. (Candelaria consists of three or four houses).

Report received that a group of bandits had arrived at San Pablo apparently from the north, and that questions regarding the whereabouts of Guardia patrols were being asked. Last night a message from Villanueva stated that a large group of bandits had arrived and were then about two leagues from that place. The message stated that this group came from the south. The Jefe Politico had the information regarding the presence of a group near Villanueva. Information was received that late yesterday afternoon the bandits were in Las Grietas and were heading towards San Juan.

A number of shots were fired just outside of Chichigalpa last night and on investigation it was found that the firing had been done by four mounted on horses who escaped in the darkness. Rumors of a group of 25 bandits in the came fields of San Antonio were received but not confirmed.

Patrols are located in general as follows:

Captain Trumble at San Juan with that place as his base.

Captain Erauer at Obraje with that place as his base.

Lieutenant Shuler enroute to Obraje from Dan Oristobal.

Lieutenant Spart in tha vicinity of Campuzano.

"Captain Elmore with his and Darrah's patrol were in Las Grietas during the night. They will be in Artentina to-day.

Lieutenant Clark probably at Bellavista ordered to Villanueva.

Lieutenant Griffiths when last heard of was in possession of the information regarding the bandits at San Pablo. His ultimate destination was Olomega.

Organization of patrol:

Point: Lt. Brannon and 7 enlisted (1 TSMG, 1 rifle grenadier, 5 riflemen).

Main Body: Camp. Schwerin and 17 enlisted (2 TSH), 2 BAR, 2 rifle grenadiers, 11 riflemen).

Mear Guard: 1 Sgto, 5 other enlisted (riflemen) with

4 pack animals.

Note: Carried 15 grenades for each rifle grenadier, 2 drums and 100 extra rounds for each TSLG, 16 magazines for each BAR, 160 rounds for each riflemen.

Operations:

Feb. 12 - 0730 - Cleared Corinto Finca, crossed Rio Tuna at 139-243, combed trails between CALRETERA (143-247) and STA ISABEL (141-249).

1630 - Arrived at STA ISABEL and spent night.

Feb. 13 - 0700 - Cleared STA ISABEL to north, thru CIERRA MOREMA (139-253), covered various trails in this area.

1600 - Returned to CIERRA MORENA, spent night.

Peb. 14 - 0700 - Cleared CIERRA MORENA for LOS ANGELES (144-259) via SAN ANTONIO (138-256). Halfway between SAN ANTONIO and LOS ANGELES at point 141-258 patrol was ambushed at 11:45 am. After contact and failure to regain contact with bandits started return to Corinto Finea with body of one Juardia, killed in contact. Travelled via SLN ANTO-NIO and CONSTANCIA (136-252).

1910 - Arrived at CORINTO PINCA.

Report of contact:-On the trail between San Antonio and Los Anteles at about 11:45 am, 14 February 1932, fire was first opened on the point. A shot from the first burst hit Raso hercedes horales #4503, GN, in the head, killing him instantly. The trail at this point is wooded on both sides with heavy brush on the border of the woods. The ambush was laid in the woods on the north side of trail. Fire was then opened on the whole colum. The patrol took cover and opened a heavy fire on the bandit position. After about fifteen minutes I ordered the point to hold the trail and with the main body I rushed the woods, broke thru the brush; the bandits ceases firing and took off down the hill thru the woods and scattered to the north. The contact ended at 12:10 PM. The patrol remained on the scene of contact until 13.00, endeavoring to pick up some trail of the bandits but this

was impossible, so decided to return to Corinto Minca with the body of kaso Morales. I estimate the bandit group to be between 60 and 70, armed with one Lewis machine gun and three Thompsons, jefe unknown. Upon our entrance into the woods, signs of blood were seen in numerous spots and it is my opinion that quite a few of the bandits were wounded by the Guardia fire. The Guardia suffered no other casualties than the one at the first burst of fire.

- 7. The entire patrol were cool under fire and when ordered to enter the woods acted without hesitation.
- 8. It is my opinion that the entire area immediately north of the Tuma River is being occupied by reving groups of bandits, camping off the main trails, that they will endeavor to ambush Guardia patrols only when they can take positions from which they can easily escape by scattering when the Guardia fire and attack become too aggresive.
- 9. The trails are getting in better conditions due to the rains having let up for the past week or ten days.

Contact of Civicos, Neptune Line.

- 1. On report that a group of bandits that had robbed Tunkey were in the vicinity of BigFalls (110.4-300.9) a patrol of seven civicos under command of Pedro Jarquin, (civilian) armed with Krag Rifles, encountered a group of six bandits near the Biltigni River (110-6-310.1). This group were cutting balsa wood to be used in rafts. They were surprised at this work and four of their number killed and two Muzzle loading shotguns captured. A small quantity of black powder was captured.
- 2. The action of these civicos who left Big Palls (Power Plan of Neptune Mine) of their own accord; acting on their own information is very commondable, especially of Pedro Jarquin who lead the patrol. This contact occurred about 1000 1 February 1932.
